Reimbursement for such services must be provided in an amount that equals not less than 80 31 32 percent of the reimbursement to a physician who provides the 33 same services, unless otherwise provided for in the General 34 Appropriations Act. The agency shall also pay for services provided to a recipient by a licensed advance practice 35 36 registered nurse who is registered to engage in autonomous 37 practice under s. 464.0123.
