27 Notwithstanding any language contained elsewhere in (1) 28 this act to the contrary, the trustees are hereby authorized and empowered to own, lease, establish, acquire or construct, erect, 29 30 equip, maintain, and operate, both within and beyond the 31 boundaries of Holmes County, in addition to hospitals, all 32 manner of other health care facilities and all manner of other 33 health care services that promote the public health and the health care needs of those members of the public served by the 34 said corporation, subject to the provisions of sections 408.031-35 36 408.0455, Florida Statutes. 37 The trustees are authorized and empowered to contract (m) 38 with individuals, partnerships, corporations, municipalities, 39 the county, the state, and any subdivision or agency thereof in the United States of America, to carry out the purposes of this 40 41 act, including participation in the joint provision with other 42 hospitals and health care providers of all manner of inpatient 43 and outpatient facilities and health care services that provide 44 benefits to those members of the public served by the hospital 45 or hospitals of the Holmes county hospital corporation both 46 within and beyond the boundaries of the said corporation and to 47 the extent such participation is consistent with all 48 restrictions contained in the Florida Constitution, the general 49 laws of the state, or the provisions of sections 408.031-50 408.0455, Florida Statutes.

51 The trustees shall have and exercise all powers (n) 52 necessary, incidental, or convenient to effect any or all of the 53 purposes for which the Holmes County hospital corporation or the 54 board of trustees are organized under the provisions of this 55 act. 56 (o) It is the express intent of the Legislature that any 57 ad valorem tax or non-ad valorem special assessment revenues 58 levied by Holmes County be used solely toward health care 59 facilities or health care services within Holmes County. 60 Accordingly, the trustees are expressly prohibited from using any ad valorem or non-ad valorem special assessment revenues 61 62 levied by Holmes County on property located within Holmes County for any purpose outside the boundaries of Holmes County. 63 64 Section 2. If any section, paragraph, sentence, clause, 65 phrase, or other part of this act shall be declared 66 unconstitutional, or if this act should be declared inapplicable 67 in any case, such declaration shall not affect the remainder of 68 this act or the applicability thereof in any other case. 69 Section 3.
