 2           An act relating to transportation facility  
 3           designations; providing honorary designations of  
 4           certain transportation facilities in specified  
 5           counties; directing the Department of Transportation  
 6           to erect suitable markers; providing an effective  
 7           date.

 9   Be It Enacted by the Legislature of the State of Florida:

10  
 11           Section 1.   Transportation facility designations;  
 12           Department of Transportation to erect suitable markers.—

13           (1) That portion of S.R. 87 between E. Bay Boulevard and  
 14           U.S. 98 in Santa Rosa County is designated as "Ira Mae Bruce  
 15           Memorial Highway."

16           (2) That portion of Davie Boulevard between S.W. 34th  
 17           Avenue and S.W. 36th Avenue in Broward County is designated as  
 18           "Rubin Stacy Memorial Boulevard."

19           (3) Bridge number 100850 on S.R. 60/Courtney Campbell  
 20           Causeway over Old Tampa Bay in Hillsborough County is designated  
 21           as "Virginia Creighton Bridge."

22           (4) The interchange at the Florida Turnpike and U.S. 192  
 23           in Osceola County is designated as "Representative Frank  
 24           Attkisson Interchange."

25           (5) That portion of U.S. 19/S.R. 55 between U.S. 41/S.R.

26 | 45/Tamiami Trail and Palm View Road in Manatee County is  
 27 | designated as "Tiffany Marie Olson Memorial Highway."

28 | (6) That portion of S.R. 1A between Oakland Park  
 29 | Boulevard and Palm Avenue in Broward County is designated as  
 30 | "Pio R. Ieraci Memorial Highway."

31 | (7) That portion of S.R. 520/W. King Street between S.R.  
 32 | 501/Clearlake Road and S.R. 519/Fiske Boulevard in Brevard  
 33 | County is designated as "Sgt. George Lee Taylor, Sr., Memorial  
 34 | Highway."

35 | (8) That portion of S.R. 519/Fiske Boulevard between Rosa  
 36 | L. Jones Drive and I-95 in Brevard County is designated as "Dr.  
 37 | Martin Luther King, Jr., Boulevard."

38 | (9) That portion of U.S. 23/Kings Road between Spires  
 39 | Avenue and Tyler Street in Duval County is designated as  
 40 | "Professor Dock Jackson Jordan and Mrs. Carrie Thomas Jordan  
 41 | Memorial Highway."

42 | (10) That portion of S.R. 715/Bacom Point Road between W.  
 43 | Morgan Road and S.W. 14th Street in Palm Beach County is  
 44 | designated as "Deputy Sheriff Donta Manuel and Deputy Sheriff  
 45 | Jonathan Wallace Highway."

46 | (11) Upon completion of construction, the interchange at  
 47 | First Coast Expressway/S.R. 23 and Henley Road in Clay County is  
 48 | designated as "Sergeant Eric John Twisdale Memorial  
 49 | Interchange."

50 | (12) That portion of E. Main Street/Bayfront Parkway/E.

51 Gregory Street between S. Tarragona Street and the Pensacola Bay  
 52 Bridge in Escambia County is designated as "Pensacola Police  
 53 Fallen Heroes Highway."

54 (13) Bridge No. 380097 on U.S. 27 over the Fenholloway  
 55 River in Taylor County is designated as "Private Tillman R.  
 56 Clark Memorial Bridge."

57 (14) That portion of U.S. 90 between Canal Street and  
 58 Stewart Street in Santa Rosa County is designated as "Reverend  
 59 Murray Hamilton, Sr., Highway."

60 (15) The Department of Transportation is directed to erect  
 61 suitable markers designating the transportation facilities as  
 62 described in this section.

63 Section 2. This act shall take effect July 1, 2021.
