3 Representative Sabatini offered the following:

**Amendment (with title amendment)**

Remove everything after the enacting clause and insert:

7 Section 1. Effective upon this act becoming a law, the  
8 North Lake County Hospital District may not incur any additional  
9 obligations or indebtedness other than expenses incurred in the  
10 ordinary course of business and shall avoid wasting its assets.  
11 By September 30, 2022, the North Lake County Hospital District  
12 shall wind down its affairs, including, but not limited to,  
13 adopting a dissolution plan that includes liquidating all of its  
14 assets and satisfying all of its obligations and indebtedness.

15 Section 2. The North Lake County Hospital District Board  
16 of Trustees may levy taxes, in accordance with chapter 2017-219,

17 Laws of Florida, through and including September 30, 2022. Taxes  
18 collected by the tax collector after September 30, 2022,  
19 pursuant to a levy adopted by the board of trustees before  
20 October 1, 2022, shall be paid to the Board of County  
21 Commissioners of Lake County for disposition in accordance with  
22 section 6 of this act.

23 Section 3. Chapters 2012-258 and 2017-219, Laws of  
24 Florida, are repealed effective October 1, 2022.

25 Section 4. Notwithstanding any law to the contrary, the  
26 North Lake County Hospital District is dissolved effective  
27 October 1, 2022.

28 Section 5. The responsibilities of the North Lake County  
29 Hospital District as an issuing authority under any and all  
30 outstanding bond issues are transferred to the Board of County  
31 Commissioners of Lake County effective October 1, 2022. The  
32 transferred responsibilities may not constitute a debt or an  
33 obligation of the county.

34 Section 6. Notwithstanding any law to the contrary,  
35 effective October 1, 2022, all remaining assets and liabilities  
36 of the North Lake County Hospital District are transferred to  
37 the Board of County Commissioners of Lake County. All assets  
38 received by the board of county commissioners pursuant to this  
39 section shall first be used to satisfy all liabilities of the  
40 former district received pursuant to this section. All assets  
41 remaining after the satisfaction of former district liabilities

42 shall be used by the board of county commissioners in accordance  
43 with the dissolution plan adopted by the North Lake County  
44 Hospital District Board of Trustees before October 1, 2022,  
45 provided such plan is consistent with chapter 2012-258, Laws of  
46 Florida, and provides for the expenditure of district funds only  
47 within the boundaries of the former North Lake County Hospital  
48 District.

49 Section 7. This act shall take effect upon becoming a law.

55 County; prohibiting the district from incurring certain  
56 additional obligations or indebtedness; requiring the district  
57 to wind down its affairs, liquidate its assets, and satisfy its  
58 obligations and indebtedness by a specified date; providing for  
59 disposition of certain taxes collected; repealing chs. 2012-258  
60 and 2017-219, Laws of Florida; dissolving the district on a  
61 specified date; transferring certain district responsibilities  
62 and assets and liabilities to the Board of County Commissioners  
63 of Lake County; providing an effective date.
