| 16 | state for at least 5 years immediately preceding appointment. In |

30 or state-recognized appraisal organization may shall not be a 31 prerequisite to membership on the board. To the extent possible, no more than two members of the board shall be primarily 32 33 affiliated with any one particular national or state appraisal 34 association. Two of the members must be licensed or certified 35 residential real estate appraisers and two of the members must 36 be certified general real estate appraisers at the time of their 37 appointment.

38 (a) Members of the board shall be appointed for 4-year 39 terms. Any vacancy occurring in the membership of the board 40 shall be filled by appointment by the Governor for the unexpired term. Upon expiration of her or his term, a member of the board 41 42 shall continue to hold office until the appointment and 43 qualification of the member's successor. A member may not be 44 appointed for more than two consecutive terms. The Governor may 45 remove any member for cause.

(b) The headquarters for the board shall be in Orlando.

47 (c) The board shall meet at least once each calendar48 quarter to conduct its business.

(d) The members of the board shall elect a chairperson atthe first meeting each year.

(e) Each member of the board is entitled to per diem and
travel expenses as set by legislative appropriation for each day
that the member engages in the business of the board.
