Remove line 1458 and insert:

Section 34. Effective upon this act becoming a law, section 19 of chapter 9820 (1923), Laws of Florida, is amended to read:

~~Section 19. It shall be the duty of the City Clerk and Auditor to keep correct minutes of the proceedings of the City Commission and enter the same in a suitable book to be kept for the purpose. He shall also see that the minutes are promptly printed in some newspaper published in the City. The Mayor-Commissioner and the City Clerk and Auditor shall sign each and every minute of the Council, when duly recorded in the minute book. It shall also be the duty of said City Clerk and Auditor~~

17 ~~to record all ordinances and resolutions passed by the said City~~  
18 ~~Commission after the approval of the same by the Mayor in the~~

22 Section 35. Effective upon this act becoming a law,

27 ~~County, Florida, provided, however, that the cost of publishing~~
