2 An act relating to prohibited governmental
3 transactions with technology companies and for Chinese
4 products; creating s. 287.137, F.S.; providing a
5 definition; prohibiting an agency or local
6 governmental entity from purchasing any good made, or
7 that contains a specified percentage of parts that
8 were produced, in China; providing that a contract for
9 the purchase of goods by an agency or local
10 governmental entity must include a provision
11 authorizing the termination of such contract in
12 certain circumstances; creating s. 287.138, F.S.;
13 providing a definition; prohibiting an agency or local
14 governmental entity from purchasing any good or
15 service made, sold, or provided by certain technology
16 companies; providing that a contract for the purchase
17 or provision of goods or services by an agency or
18 local governmental entity must include a provision
19 authorizing the termination of such contract in
20 certain circumstances; providing effective dates.

22 Be It Enacted by the Legislature of the State of Florida:

24 Section 1. Effective January 1, 2023, section 287.137,
25 Florida Statutes, is created to read:

26 287.137 Prohibition against purchasing goods made in
 27 China.-

28 (1) As used in this section, the term "local governmental
 29 entity" means a county, municipality, special district, or other
 30 political subdivision of the state.

31 (2) An agency or local governmental entity may not
 32 purchase or enter into or renew a contract for the purchase of
 33 any good made, or that contains at least 25 percent or more
 34 parts that were produced, in China.

35 (3) Any contract with an agency or local governmental
 36 entity for the purchase of goods entered into or renewed on or
 37 after January 1, 2023, must contain a provision that authorizes
 38 the termination of such contract at the option of the awarding
 39 body if the company is found to be providing the agency or local
 40 governmental entity with goods made, or that contains at least
 41 25 percent or more parts that were produced, in China.

42 Section 2. Section 287.138, Florida Statutes, is created
 43 to read:

44 287.138 Prohibition against purchasing goods from or
 45 contracting with certain technology companies.-

46 (1) As used in this section, the term "local governmental
 47 entity" means a county, municipality, special district, or other
 48 political subdivision of the state.

49 (2) An agency or local governmental entity may not
 50 purchase, or enter into or renew a contract for the purchase or

51 provision of, any good or service made, sold, or provided by
52 Facebook, Inc.; Twitter, Inc.; Amazon.com, Inc.; Apple, Inc.; or
53 Alphabet, Inc.

54 (3) Any contract with an agency or local governmental
55 entity for the purchase or provision of goods or services
56 entered into or renewed on or after July 1, 2021, must contain a
57 provision that authorizes the termination of such contract at
58 the option of the awarding body if the company is found to be
59 providing the agency or local governmental entity with goods
60 made or services provided by Facebook, Inc.; Twitter, Inc.;
61 Amazon.com, Inc.; Apple, Inc.; or Alphabet, Inc.

62 Section 3. Except as otherwise expressly provided in this
63 act, this act shall take effect July 1, 2021.
