(a) The lesser of 14.5453 ~~24.18442~~ percent of the remainder or \$330.31 million ~~\$541.75 million~~ in each fiscal year shall be paid into the State Treasury to the credit of the State Transportation Trust Fund. ~~Of such funds, \$75 million for each fiscal year shall be transferred to the General Revenue Fund.~~
