21 resignation submitted by the official in his or her letter of  
22 resignation.

23           (4) (g) ~~Notwithstanding the provisions of any special act~~

25 ~~resignation creates a vacancy in office to be filled by~~  
26 ~~election, thereby authorizing persons to qualify as candidates~~  
27 ~~for nomination and election as if the officer's term were~~

29 ~~charter county office or elective municipal office, the vacancy~~
