## Senate Amendment (with title amendment)

Delete everything after the enacting clause and insert:

Section 1. Present subsections (2) through (8) of section 465.189, Florida Statutes, are redesignated as subsections (3) through (9), respectively, a new subsection (2) is added to that section, and subsection (1) and present subsection (6) are amended, to read:

- (1) In accordance with guidelines of the Centers for Disease Control and Prevention for each recommended immunization or vaccine, a pharmacist, or a registered intern under the supervision of a pharmacist who is certified under subsection  $(7) \frac{(6)_{T}}{(7)^{T}}$  may administer the following immunizations or vaccines to an adult within the framework of an established protocol under a supervising physician licensed under chapter 458 or chapter 459:
- (a) Immunizations or vaccines listed in the Adult Immunization Schedule as of February 1, 2015, by the United States Centers for Disease Control and Prevention's Recommended Immunization Schedule, the United States Centers for Disease Control and Prevention's Health Information for International Travel, or the United States Food and Drug Administration's Vaccines Licensed for Use in the United States or vaccines authorized for emergency use by the United States Food and Drug Administration Prevention. The board may authorize, by rule, additional immunizations or vaccines as they are added to the United States Centers for Disease Control and Prevention's Recommended Immunization Schedule, the United States Centers for Disease Control and Prevention's Health Information for International Travel, or the United States Food and Drug Administration's Vaccines Licensed for Use in the United States or additional vaccines authorized for emergency use by the United States Food and Drug Administration Adult Immunization Schedule.
- (b) Immunizations or vaccines recommended by the United States Centers for Disease Control and Prevention for

international travel as of July 1, 2015. The board may authorize, by rule, additional immunizations or vaccines as they are recommended by the United States Centers for Disease Control and Prevention for international travel.

(c) Immunizations or vaccines approved by the board in response to a state of emergency declared by the Governor pursuant to s. 252.36.

A registered intern who administers an immunization or vaccine 48 49 under this subsection must be supervised by a certified

pharmacist at a ratio of one pharmacist to one registered intern.

(2) A pharmacist who is certified under subsection (7) may administer influenza vaccines to individuals 7 years of age or older within the framework of an established protocol under a supervising physician licensed under chapter 458 or chapter 459.

(7)<del>(6)</del> Any pharmacist or registered intern seeking to administer vaccines to adults under this section must be certified to administer such vaccines pursuant to a certification program approved by the Board of Pharmacy in consultation with the Board of Medicine and the Board of Osteopathic Medicine. The certification program shall, at a minimum, require that the pharmacist attend at least 20 hours of continuing education classes approved by the board and the registered intern complete at least 20 hours of coursework approved by the board. The program shall have a curriculum of instruction concerning the safe and effective administration of such vaccines, including, but not limited to, potential allergic reactions to such vaccines.



Section 2. This act shall take effect July 1, 2021.
