Remove lines 27-77 and insert:

7 with section 189.031(3)~~189.404(3)~~, Florida Statutes, the  
 8 following subsections constitute the charter of the St. Johns  
 9 ~~St. Augustine-St. Johns~~ County Airport Authority:

10 (1) There is hereby created an authority to be known as  
 11 the St. Johns ~~St. Augustine-St. Johns~~ County Airport Authority  
 12 with the power to sue and be sued and with the additional powers  
 13 specified herein.

14 (2) There is also created a special taxing district in St.  
 15 Johns County, which district shall be a body politic and  
 16 corporate and political subdivision of the state under the name

17 of "St. Johns ~~St. Augustine~~ ~~St. Johns~~ County Airport Authority  
18 District." The St. Johns ~~St. Augustine~~ ~~St. Johns~~ County Airport  
19 Authority shall be the governing body and shall exercise its  
20 powers and jurisdiction within the territory of said district,  
21 which shall comprise all of St. Johns County.

22 (3) The St. Johns ~~St. Augustine~~ ~~St. Johns~~ County Airport  
23 Authority shall be governed by a board of five members known as  
24 the St. Johns ~~St. Augustine~~ ~~St. Johns~~ County Airport Authority  
25 board. The expiration of each 4-year term for each seat is  
26 staggered, such that two or three of the five seats are elected  
27 every 2 years. At the general election held prior to the  
28 expiration of each of said terms, successors shall be elected by  
29 the qualified electors residing within the boundaries of the St.  
30 Johns ~~St. Augustine~~ ~~St. Johns~~ County Airport Authority District  
31 for a term of 4 years, to expire the first Tuesday after the  
32 first Monday in January following the election. Vacancies in  
33 office shall be filled by appointment of the Governor and  
34 confirmed by the Senate for the remainder of the unexpired  
35 terms. No member of the St. Johns ~~St. Augustine~~ ~~St. Johns~~ County  
36 Airport Authority board shall be an officer or employee of the  
37 City of St. Augustine, St. Johns County, or the State of  
38 Florida, except members of the militia or notaries public. Not  
39 more than two of the members shall be persons who are primarily  
40 engaged in the aviation business, and no person shall be  
41 eligible for appointment or election as a board member except

42 persons residing within the boundaries of the St. Johns St.  
43 ~~Augustine St. Johns~~ County Airport Authority District. The  
44 members constituting the St. Johns St. ~~Augustine St. Johns~~  
45 County Airport Authority board shall select one of their number  
46 as chair, and the term of office of the chair shall be 1 year.  
47 The members shall receive no compensation for their service, but  
48 they are authorized to be reimbursed for verified travel and  
49 other expenses, which shall be paid from the funds of the  
50 Authority. Three members shall constitute a quorum for the
