 1095 Section 2. Notwithstanding s. 561.20(1), Florida Statutes,

1105 and beverage revenue from the sale of food and nonalcoholic  
1106 beverages during the first 60-day operating period and each 12-  
1107 month operating period thereafter. Failure of any licensee  
1108 issued this special license to meet the required percentage of  
1109 food and nonalcoholic beverage gross revenues during the covered  
1110 operating period shall result in the revocation of the license  
1111 or denial of the pending application for a permanent license of  
1112 a licensee operating with a temporary license. A licensee whose
