**Senate Amendment (with title amendment)**

Delete everything after the enacting clause  
and insert:

Section 1. Transportation facility designations; Department  
of Transportation to erect suitable markers.-

(1) That portion of S.R. 715/Bacom Point Road between W.  
Morgan Road and S.W. 14th Street in Palm Beach County is  
designated as "Deputy Sheriff Donta Manuel and Deputy Sheriff  
Jonathan Wallace Highway."

(2) Bridge number 100850 on S.R. 60/Courtney Campbell

12 Causeway over Old Tampa Bay in Hillsborough County is designated  
13 as "Virginia Creighton Bridge."

14 (3) The intersection of S.W. 23rd Avenue and S.W. 8th  
15 Street in Miami-Dade County is designated as "Arturo Diaz  
16 Artiles Plaza."

17 (4) That portion of W. Columbus Drive between N. Himes  
18 Avenue and N. MacDill Avenue in Hillsborough County is  
19 designated as "Maximino Capdevila Road."

20 (5) That portion of S.R. 19 between C.R. 48 and Lane Park  
21 Cutoff Road in Lake County is designated as "Sergeant First  
22 Class Michael C. Aten Memorial Highway."

23 (6) Bridge number 720684 on I-95 over the Trout River in  
24 Jacksonville/Duval County is designated as "Warren Alvarez  
25 Memorial Bridge."

26 (7) That portion of U.S. 27/S.R. 25 between the Polk County  
27 line and the Glades County line in Highlands County is  
28 designated as "Deputy William Gentry, Jr., Highway."

29 (8) That portion of S.R. 100 in Clay County between the  
30 Bradford County line and the Putnam County line is designated as  
31 "Veterans Honor Highway."

32 (9) Upon completion of construction, the interchange at  
33 First Coast Expressway/S.R. 23 and Henley Road in Clay County is  
34 designated as "Sergeant Eric John Twisdale Memorial  
35 Interchange."

36 (10) That portion of S.R. A1A between the northern terminus  
37 and southern terminus of Galt Ocean Drive in Broward County is  
38 designated as "Pio Ieraci Memorial Drive."

39 (11) That portion of S.R. 520/W. King Street between S.R.  
40 501/Clearlake Road and S.R. 519/Fiske Boulevard in Brevard

56 900125, between milepost 4.100 and milepost 4.169 on Overseas  
57 Highway in Monroe County is designated as "Cheryl H. Cates  
58 Memorial Bridge."

59 (17) That portion of S.R. 953/N.W. 42nd Avenue/Le Jeune  
60 Road between N.W. 11th Street and N.W. 14th Street in Miami-Dade  
61 County is designated as "Oswaldo Payá Way."

62 (18) That portion of S.R. 82 between Veronica S. Shoemaker  
63 Boulevard and Ortiz Avenue in Lee County is designated as "Coach  
64 Guy Thomas Memorial Highway."

65 (19) That portion of North University Drive between S.R.  
66 827 and the Sawgrass Expressway is designated as "Michael  
67 Moskowitz Drive."

68 (20) That portion of S.R. 408/Spessard L. Holland East-West  
69 Expressway between the Mills Avenue exit and the Rosalind Avenue

72 (21) That portion of S.R. 826/Sunny Isles Boulevard between  
73 N.E. 35th Avenue and S.R. 1A in Miami-Dade County is designated

75 (22) That portion of N.W. 12th Avenue/John Henry Peavy Jr.  
76 Avenue between N.W. 62nd Street and N.W. 71st Street in Miami-  
77 Dade County is designated as "Soul of Miami Avenue."

78 (23) Bridge number 380097 on U.S. 27 over the Fenholloway  
79 River in Taylor County is designated as "Private Tillman R.  
80 Clark Memorial Bridge."

81 (24) That portion of Matanzas Woods Parkway between Bird of  
82 Paradise Drive and Old Kings Road in Flagler County is  
83 designated as "Staff Sergeant Keon Clyde Sands Memorial  
84 Parkway."

85 (25) That portion of I-75 between the Charlotte County line  
86 bordering DeSoto County and the Lee County line bordering  
87 Collier County is designated as "Purple Heart Highway."

88 (26) That portion of U.S. 41/S.W. 8th Street between S.W.  
89 21st Avenue and S.W. 22nd Avenue in Miami-Dade County is  
90 designated as "Bellas Artes Way."

91 (27) The Department of Transportation is directed to erect  
92 suitable markers designating the transportation facilities as  
93 described in this section.
