6 Remove everything after the enacting clause and insert:
7 Section 1. Section 1 of section 3 of chapter 2001-326,
8 Laws of Florida, as amended by chapter 2006-336, Laws of
9 Florida, is amended to read:

10 Section 1. There is hereby created a Board of Trustees to
11 be known as "Board of Trustees, Rupert J. Smith Law Library of
12 Saint Lucie County," which said board shall consist of six ~~five~~
13 members; the membership of the said board shall consist of a
14 Circuit Judge who is a resident of Saint Lucie County, to be
15 designated by the Chief Judge of the Nineteenth Judicial
16 Circuit, one member of the Board of County Commissioners of

17 Saint Lucie County to be chosen by the said Board of County
18 Commissioners biennially, two active practicing attorneys who
19 reside in the Nineteenth Judicial Circuit Saint Lucie County,
20 ~~one~~ to be appointed by the ~~president of the~~ Saint Lucie County
21 Bar Association ~~and one to be appointed by the president of the~~
22 ~~Port Saint Lucie Bar Association,~~ and a two lay members, one to
23 be appointed by the president of the Friends of Saint Lucie
24 County Library Association, Inc., and one to be appointed by the
25 Board of Trustees, Rupert J. Smith Law Library of Saint Lucie
26 County. At the time this act takes effect, two attorneys shall
27 be appointed for a term of 1 year, beginning on the first
28 Tuesday after the first Monday in January of each year. The
29 Board of Trustees shall have full power and authority to
30 establish, operate, and maintain one or more law library
31 facilities within Saint Lucie County at such place or places as
32 may, from time to time, be designated by said Board of Trustees;
33 to prescribe rules and regulations as to its own functions and
34 organization; and to prescribe and enforce rules and regulations
35 as to the use, maintenance, and operation of said law library.
36 Said Board of Trustees shall purchase books, furniture,
37 equipment, and supplies either for cash or upon retained title
38 or other contracts that shall be payable solely out of said law
39 library fund and not otherwise.

40 Section 2. This act shall take effect upon becoming a law.
