Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 1 of section 3 of chapter 2001-326,
Laws of Florida, as amended by chapter 2006-336, Laws of
Florida, is amended to read:

Section 1. There is hereby created a Board of Trustees to
be known as "Board of Trustees, Rupert J. Smith Law Library of
Saint Lucie County," which said board shall consist of six ~~five~~
members; the membership of the said board shall consist of a
Circuit Judge who is a resident of Saint Lucie County, to be
designated by the Chief Judge of the Nineteenth Judicial
Circuit, one member of the Board of County Commissioners of
Saint Lucie County to be chosen by the said Board of County
Commissioners biennially, two active practicing attorneys who
reside in the Nineteenth Judicial Circuit ~~Saint Lucie County,~~
~~one~~ to be appointed by the ~~president of the~~ Saint Lucie County
Bar Association ~~and one to be appointed by the president of the~~
~~Port Saint Lucie Bar Association,~~ and two ~~a~~ lay members, ~~one~~

26 | ~~member~~ to be appointed by the president of the Friends of Saint
27 | Lucie County Library Association, Inc., and one to be appointed
28 | by the Board of Trustees, Rupert J. Smith Law Library of Saint
29 | Lucie County. At the time this act takes effect, two attorneys
30 | shall be appointed for a term of 1 year, beginning on the first
31 | Tuesday after the first Monday in January of each year. The
32 | Board of Trustees shall have full power and authority to
33 | establish, operate, and maintain one or more law library
34 | facilities within Saint Lucie County at such place or places as
35 | may, from time to time, be designated by said Board of Trustees;
36 | to prescribe rules and regulations as to its own functions and
37 | organization; and to prescribe and enforce rules and regulations
38 | as to the use, maintenance, and operation of said law library.
39 | Said Board of Trustees shall purchase books, furniture,
40 | equipment, and supplies either for cash or upon retained title
41 | or other contracts that shall be payable solely out of said law
42 | library fund and not otherwise.

43 | Section 2. This act shall take effect upon becoming a law.
