Be It Enacted by the Legislature of the State of Florida:

Section 1. The trustees of the Internal Improvement Trust Fund shall convey to the District Board of Trustees of Indian River State College, in fee simple, and for all uses as permitted by law, the following described real property located in St. Lucie County and more particularly described as follows:

A parcel of land lying in Sections 23, 24, 25, and 26, Township 36 South, Range 39 East, St. Lucie County, Florida being further described as:

Begin at the Southeast corner of Parcel 29A, as shown on St. Lucie West Plat No. 1, Prima Vista Boulevard, as recorded in Plat Book 26, Pages 8, 8A through 8G,

26 Public Records of St. Lucie County, Florida; thence
27 run North 03°20'05" West along the Easterly line of
28 said Parcel 29A a distance of 1328.73 feet; thence run
29 North 80°04'07" East a distance of 886.64 feet; thence
30 run North 89°19'33" East a distance of 628.92 feet;
31 thence run South 00°40'27" East a distance of 634.29
32 feet to a point of curvature; thence run Southwesterly
33 along the arc of a curve concave to the Northwest with
34 radius of 1456.74 feet and central angle of 30°40'27"
35 a distance of 779.89 feet to a point of reverse
36 curvature; thence run Southwesterly along the arc of a
37 curve concave to the Southeast with radius of 1576.74
38 feet and a central angle of 11°51'49" a distance of
39 326.48 feet to a point of reverse curvature; thence
40 run Southwesterly along the arc of a curve concave to
41 the Northwest with radius of 25.00 feet and central
42 angle of 77°10'49" a distance of 33.68 feet to a point
43 of compound curvature; thence run Northwesterly along
44 the arc of a curve concave to the Northeast with
45 radius of 3744.72 feet and central angle of 08°34'36"
46 a distance of 560.55 feet to a point of tangency;
47 thence run North 76°06'24" West a distance of 192.72
48 feet to a point of curvature; thence run Northwesterly
49 along the arc of a curve concave to the Southwest with
50 radius of 3858.28 feet and central angle of 05°08'14"

51 a distance of 345.95 feet to the Point of the
52 Beginning.

54 Also known as Parcel 27C, Tract 27G,
55 Conservation/Buffer Zone Tracts 41B, 42B, and 44,
56 St. Lucie West Plat No. 34-Parcel 27-Phase 1,
57 according to the Plat thereof on file in the Office of
58 the Clerk of Circuit Court in and for St. Lucie
59 County, Florida recorded in Plat Book 34, Page 2, and
60 2A through 2E; said land situate, lying and being in
61 St. Lucie County.

63 Section 2. (1) The District Board of Trustees of Indian
64 River State College shall manage and protect the real property
65 described in section 1, and use the property continuously for
66 educational means and purposes pursuant to ss. 1001.64 and
67 1004.65, Florida Statutes.

68 (2) Any sale or disposition of the real property described
69 in section 1 by the District Board of Trustees of Indian River
70 State College may result in ownership of the property reverting
71 back to the Board of Trustees of the Internal Improvement Trust
72 Fund on behalf of the state.

73 Section 3. The Trustees of the Internal Improvement Trust
74 Fund shall convey the real property described in section 1 to
75 the District Board of Trustees of Indian River State College
