	(a) Is not required to be separately covered, have
16	overhead protection or hoods, or be enclosed. However, outdoor
17	kitchen equipment must meet all other applicable laws, codes,
18	standards, and rules, including for fire safety and sanitation.
19	(b) May be used to prepare, serve, or sell food for
20	immediate consumption as provided in this chapter. Any food that
21	is prepared on outdoor kitchen equipment must be kept at
22	appropriate temperatures and prepared using sanitation
