13 (16) TEACHER SALARY INCREASE ALLOCATION.—The Legislature
14 may annually provide in the Florida Education Finance Program a
15 teacher salary increase allocation to assist school districts in
16 their recruitment and retention of classroom teachers and other
17 instructional personnel. The amount of the allocation shall be
18 specified in the General Appropriations Act.

19 (a) Each school district shall receive an allocation based
20 on the school district's proportionate share of the base FEFP
21 allocation. Each school district shall provide each charter
22 school within its district its proportionate share calculated
23 pursuant to s. 1002.33(17)(b). If a district school board has
24 not received its allocation due to its failure to submit an
25 approved district salary distribution plan, the district school
26 board must still provide each charter school that has submitted
27 a salary distribution plan within its district its proportionate
28 share of the allocation.

29 (c) Before distributing allocation funds received pursuant
30 to paragraph (a), each school district and each charter school
31 shall develop a salary distribution plan that clearly delineates
32 the planned distribution of funds pursuant to paragraph (b) in
33 accordance with modified salary schedules, as necessary, for the
34 implementation of this subsection.
