11 Section 1. Section 15 of chapter 2005-346, Laws of  
12 Florida, is amended to read:

13 Section 15. On December 31, 2032~~2030~~, this law shall  
14 expire and all assets of the authority shall on or before that  
15 date be transferred by the authority to the city. Any assets  
16 remaining in the hands of the authority on December 31,

18 | property of the city. In the event there shall be any  
19 | indebtedness outstanding against the authority, the city may  
20 | continue to levy whatever portion shall be necessary of the tax

22 |       Section 2. Referendum. Notwithstanding the requirement for  
23 | a board resolution in section 18(1) of section 3, of chapter  
24 | 2005-346, Laws of Florida, the board by resolution shall call  
25 | for a referendum of the authorized voters to be conducted no  
26 | later than 3 months from the effective date of this act. The  
27 | referendum shall comply with the requirements of section 18 of  
28 | section 3, of chapter 2005-346, Laws of Florida. The referendum
