32	(d) A description of distinguishing physical
33	characteristics of the unidentified person, including height,
34	weight, gender, race, hair and eye color, and any facial hair,
35	scars, and tattoos.
36	(2) Before entering any information into the directory, a
37	hospital shall first inform the unidentified person that his or
38	her personal identifying information will be included in the
39	directory and may be disclosed to the public upon request. The
40	hospital shall provide the unidentified person with the
41	opportunity to restrict or prohibit the inclusion in the
42	directory of any of the information specified in subsection (1)
43	or the disclosure of such information. If an unidentified person
44	cannot reasonably be informed of inclusion in the directory due
