- d. Is culturally competent and appropriate for use with young people of any race, sex, gender identity, sexual orientation, or ethnic or cultural background;
- e. Develops healthy attitudes and behaviors concerning growth, development, and body image;
- f. Encourages young people to practice healthy life
 skills, including negotiation and refusal skills, to assist in
 overcoming peer pressure and use effective decisionmaking skills
 to avoid high-risk activities;
- g. Promotes self-esteem and positive interpersonal skills, focusing on skills needed to develop healthy relationships and interactions, and provides young people with the knowledge and skills necessary to have healthy, positive, and safe relationships and behaviors; and
- h. Includes medically accurate information about all methods of contraception and each method's effectiveness rate, including, but not limited to, abstinence.
- 2. "Developmentally and age appropriate" means suitable for particular ages or age groups of children and adolescents based on the developing cognitive, emotional, and behavioral capacity typical for that age or age group.

"Medically accurate information" means information relevant to informed decisionmaking that is based on scientific evidence, consistent with generally recognized scientific theory, conducted under accepted scientific methods, published in peer-reviewed journals, and recognized as accurate, objective, and complete by mainstream professional organizations, including, but not limited to, the American Medical Association, the American College of Obstetricians and Gynecologists, the American Public Health Association, and the American Academy of Pediatrics; government agencies, including the United States Centers for Disease Control and Prevention, the United States Food and Drug Administration, and the National Institutes of Health; and scientific advisory groups, including the Institute of Medicine and the Advisory Committee on Immunization Practices. The deliberate withholding of information that is needed to protect the life and health of an individual is considered medically inaccurate.
- (a) Teach abstinence from sexual activity outside of marriage as the expected standard for all school-age students while teaching the benefits of monogamous heterosexual marriage.
