 12 Section 1. Paragraph (a) of subsection (7) of section
 13 112.313, Florida Statutes, is amended to read:

14 112.313 Standards of conduct for public officers,
 15 employees of agencies, and local government attorneys.—

16 (7) CONFLICTING EMPLOYMENT OR CONTRACTUAL RELATIONSHIP.—

17 (a)1. No public officer or employee of an agency shall
 18 have or hold any employment or contractual relationship with any
 19 business entity or any agency which is subject to the regulation
 20 of, or is doing business with, an agency of which he or she is
 21 an officer or employee, excluding those organizations and their
 22 officers who, when acting in their official capacity, enter into
 23 or negotiate a collective bargaining contract with the state or
 24 any municipality, county, or other political subdivision of the
 25 state; nor shall an officer or employee of an agency have or

26 | hold any employment or contractual relationship that will create
27 | a continuing or frequently recurring conflict between his or her
28 | private interests and the performance of his or her public
29 | duties or that would impede the full and faithful discharge of
30 | his or her public duties.

31 | ~~1. When the agency referred to is that certain kind of~~
32 | ~~special tax district created by general or special law and is~~
33 | ~~limited specifically to constructing, maintaining, managing, and~~
