5 Section 24. Subsection (3) of section 1006.12, Florida  
6 Statutes, is amended to read:

7 1006.12 Safe-school officers at each public school.—For  
8 the protection and safety of school personnel, property,  
9 students, and visitors, each district school board and school  
10 district superintendent shall partner with law enforcement  
11 agencies or security agencies to establish or assign one or more  
12 safe-school officers at each school facility within the  
13 district, including charter schools. A district school board

14 must collaborate with charter school governing boards to  
15 facilitate charter school access to all safe-school officer  
16 options available under this section. The school district may  
17 implement any combination of the options in subsections (1)-(4)

20 (3) SCHOOL GUARDIAN.—At the school district's or the  
21 charter school governing board's discretion, as applicable,  
22 pursuant to s. 30.15, a school district or charter school  
23 governing board may participate in the Chris Hixon, Coach Aaron  
24 Feis, and Coach Scott Beigel Guardian Program to meet the  
25 requirement of establishing a safe-school officer. The following  
26 individuals may serve as a school guardian, in support of  
27 school-sanctioned activities for purposes of s. 790.115, upon  
28 satisfactory completion of the requirements under s. 30.15(1)(k)  
29 and certification by a sheriff:

30 (a) A school district employee or personnel, as defined  
31 under s. 1012.01, or a charter school employee, as provided  
32 under s. 1002.33(12)(a), who volunteers to serve as a school  
33 guardian in addition to his or her official job duties; or

34 (b) An employee of a school district or a charter school  
35 who is hired for the specific purpose of serving as a school  
36 guardian.

38 | If a district school board, through its adopted policies,  
 39 | procedures, or actions, denies a charter school access to any  
 40 | safe-school officer options pursuant to this section, the school  
 41 | district must assign a school resource officer or school safety  
 42 | officer to the charter school. Under such circumstances, the  
 43 | charter school's share of the costs of the school resource  
 44 | officer or school safety officer may not exceed the safe school  
 45 | allocation funds provided to the charter school pursuant to s.  
 46 | 1011.62(12) and shall be retained by the school district.
