6 Section 1. Paragraph (c) of subsection (1) of section
7 320.08, Florida Statutes, is amended to read:

8 320.08 License taxes.—Except as otherwise provided herein,
9 there are hereby levied and imposed annual license taxes for the
10 operation of motor vehicles, mopeds, tri-vehicles as defined in
11 s. 316.003, and mobile homes as defined in s. 320.01, which
12 shall be paid to and collected by the department or its agent
13 upon the registration or renewal of registration of the
14 following:

15 (1) MOTORCYCLES AND MOPEDS.—

16 (c) Upon registration of a motorcycle, motor-driven cycle,
17 or moped, in addition to the license taxes specified in this
18 subsection, a nonrefundable motorcycle safety education fee in
19 the amount of \$2.50 shall be paid. The proceeds of such
20 additional fee shall be deposited in the Highway Safety
21 Operating Trust Fund to fund a motorcycle driver improvement
22 program implemented pursuant to s. 322.025 ~~or~~ the Florida
23 Motorcycle Safety Education Program established in s. 322.0255~~7~~
24 ~~or the general operations of the department. The department~~
25 shall submit an annual report to the President of the Senate and
26 the Speaker of the House of Representatives outlining the
27 revenues collected by the fee, funds and methods used to
28 administer motorcycle safety and awareness programs, and an
29 estimate of the number of persons exposed to such efforts.

30 Section 2. This act shall take effect October 1, 2023.
