Section 1. Paragraph (a) of subsection (1) of section 322.051, Florida Statutes, is amended to read:

322.051 Identification cards.-

- (1) Any person who is 5 years of age or older, or any person who has a disability, regardless of age, who applies for a disabled parking permit under s. 320.0848, may be issued an identification card by the department upon completion of an application and payment of an application fee.
- (a) The application must include <u>all of</u> the following information regarding the applicant:
- <u>b.</u> Gender <u>designation</u>, <u>which must provide for male</u>, <u>female</u>, <u>or nonbinary designation</u>.
- $\underline{\text{c.}}$  Proof of social security card number satisfactory to the department, which may include a military identification card.
  - d. County of residence.

  - 2. Proof of birth date satisfactory to the department.
- 3. Proof of identity satisfactory to the department. Such proof must include one of the following documents issued to the applicant:
- a. A driver license record or identification card record from another jurisdiction that required the applicant to submit a document for identification which is substantially similar to a document required under sub-subparagraph b., sub-subparagraph c., sub-subparagraph d., sub-subparagraph e., sub-subparagraph f., sub-subparagraph g., or sub-subparagraph h.;
  - b. A certified copy of a United States birth certificate;
  - c. A valid, unexpired United States passport;
- d. A naturalization certificate issued by the United States Department of Homeland Security;
- e. A valid, unexpired alien registration receipt card
  (green card);
- f. A Consular Report of Birth Abroad provided by the United States Department of State;
- g. An unexpired employment authorization card issued by the United States Department of Homeland Security; or
- h. Proof of nonimmigrant classification provided by the United States Department of Homeland Security, for an original identification card. In order to prove nonimmigrant classification, an applicant must provide at least one of the

following documents. In addition, the department may require applicants to produce United States Department of Homeland Security documents for the sole purpose of establishing the maintenance of, or efforts to maintain, continuous lawful presence:

- (I) A notice of hearing from an immigration court scheduling a hearing on any proceeding.
- (II) A notice from the Board of Immigration Appeals acknowledging pendency of an appeal.
- (III) A notice of the approval of an application for adjustment of status issued by the United States Citizenship and Immigration Services.
- (IV) An official documentation confirming the filing of a petition for asylum or refugee status or any other relief issued by the United States Citizenship and Immigration Services.
- (V) A notice of action transferring any pending matter from another jurisdiction to Florida, issued by the United States Citizenship and Immigration Services.
- (VI) An order of an immigration judge or immigration officer granting relief that authorizes the alien to live and work in the United States, including, but not limited to, asylum.
- (VII) Evidence that an application is pending for adjustment of status to that of an alien lawfully admitted for permanent residence in the United States or conditional permanent resident status in the United States, if a visa number is available having a current priority date for processing by the United States Citizenship and Immigration Services.
  - (VIII) On or after January 1, 2010, an unexpired foreign

passport with an unexpired United States Visa affixed, accompanied by an approved I-94, documenting the most recent admittance into the United States.

An identification card issued based on documents required in sub-subparagraph g. or sub-subparagraph h. is valid for a period not to exceed the expiration date of the document presented or 1 year, whichever occurs first.

322.08 Application for license; requirements for license and identification card forms.—

- (2) Each such application shall include <u>all of</u> the following information regarding the applicant:
- (a) 1. Full name, which must include the applicant's +first, middle or maiden, and last names.+
- <u>2.</u> Gender <u>designation</u>, <u>which must provide for male</u>, <u>female</u>, <u>or nonbinary designation</u>.
- 3. Proof of social security card number satisfactory to the department, which may include a military identification card. $\tau$

  - 98.093 Duty of officials to furnish information relating to

deceased persons, persons adjudicated mentally incapacitated, persons convicted of a felony, and persons who are not United States citizens.—

- (2) To the maximum extent feasible, state and local government agencies shall facilitate provision of information and access to data to the department, including, but not limited to, databases that contain reliable criminal records and records of deceased persons. State and local government agencies that provide such data shall do so without charge if the direct cost incurred by those agencies is not significant.
- (g) The Department of Highway Safety and Motor Vehicles shall furnish monthly to the department:
- 1. A list of those persons whose names have been removed from the driver license database because they have been licensed in another state. The list must contain the name, address, date of birth, gender designation sex, social security number, and driver license number of each such person.
- 2. A list of those persons who presented evidence of non-United States citizenship upon being issued a new or renewed Florida driver license or Florida identification card. The list must contain the name; address; date of birth; social security number, if applicable; and Florida driver license number or Florida identification card number, as applicable, of each such person.

(b) Fees therefor shall be charged and collected as follows:

- 1. For providing lists of motor vehicle or vessel records for the entire state, or any part or parts thereof, divided according to counties, a sum computed at a rate of not less than 1 cent nor more than 5 cents per item.
- 2. For providing noncertified photographic copies of motor vehicle or vessel documents, \$1 per page.
- 3. For providing noncertified photographic copies of micrographic records, \$1 per page.
- 4. For providing certified copies of motor vehicle or vessel records, \$3 per record.
- 5. For providing noncertified computer-generated printouts of motor vehicle or vessel records, 50 cents per record.
- 6. For providing certified computer-generated printouts of motor vehicle or vessel records, \$3 per record.
- 7. For providing electronic access to motor vehicle, vessel, and mobile home registration data requested by tag, vehicle identification number, title number, or decal number, 50 cents per item.
- 8. For providing electronic access to driver license status report by name, gender designation sex, and date of birth or by driver license number, 50 cents per item.
- 9. For providing lists of licensed mobile home dealers and manufacturers and recreational vehicle dealers and manufacturers, \$15 per list.
- 10. For providing lists of licensed motor vehicle dealers, \$25 per list.
  - 11. For each copy of a videotape record, \$15 per tape.

Section 5. Subsection (5) of section 322.091, Florida Statutes, is amended to read:

322.091 Attendance requirements.-

(5) REPORTING AND ACCOUNTABILITY.—The department shall report quarterly to each school district the legal name, gender designation sex, date of birth, and social security number of each student whose driving privileges have been suspended under this section.

Section 6. Paragraph (a) of subsection (1) of section 322.14, Florida Statutes, is amended to read:

322.14 Licenses issued to drivers.-

(1)(a) The department shall, upon successful completion of all required examinations and payment of the required fee, issue to every qualified applicant a printed driver license that must bear a color photograph or digital image of the licensee; the name of the state; a distinguishing number assigned to the licensee, which, beginning November 1, 2023, must have a minimum of four randomly generated digits on each original, renewal, or replacement driver license; and the licensee's full name, date of birth, and residence address; a brief description of the licensee, including, but not limited to, the licensee's gender designation and height; and the dates of issuance and expiration of the license. A space shall be provided upon which the licensee shall affix his or her usual signature. A license is invalid until it has been signed by the licensee except that the signature of the licensee is not required if it appears thereon in facsimile or if the licensee is not present within the state

at the time of issuance.

Section 7. Paragraphs (a) and (b) of subsection (1) of section 322.17, Florida Statutes, are amended to read:

322.17 Replacement licenses and permits.-

- (1) (a) In the event that an instruction permit or driver license issued under the provisions of this chapter is lost or destroyed, the person to whom the permit or license same was issued may, upon payment of the appropriate fee pursuant to s. 322.21, obtain a replacement upon furnishing proof satisfactory to the department that such permit or license has been lost or destroyed, and further furnishing the full name, date of birth, gender designation sex, residence and mailing address, proof of birth satisfactory to the department, and proof of identity satisfactory to the department.
- (b) In the event that an instruction permit or driver license issued under the provisions of this chapter is stolen, the person to whom the permit or license same was issued may, at no charge, obtain a replacement upon furnishing proof satisfactory to the department that such permit or license was stolen and further furnishing the full name, date of birth, gender designation sex, residence and mailing address, proof of birth satisfactory to the department, and proof of identity satisfactory to the department.

Section 8. This act shall take effect July 1, 2023.
