16	Moncada Property more particularly described below, shall be
17	added to the territorial limits of the Acme Improvement
18	District, a dependent district of the Village of Wellington,
19	existing in Palm Beach County, as codified under chapter 2003-
20	330, Laws of Florida, and shall be removed from the territorial
21	limits of the Pine Tree Water Control District, a corporation
22	under the drainage laws of the state, existing in Palm Beach
23	County, as codified under chapter 2009-270, Laws of Florida. The
24	purpose of the transfer of property from the Pine Tree Water
25	Control District to the Acme Improvement District is to

26	facilitate the incorporation of the Moncada Property into the
27	existing Wellington Preserve at the Marjory Stoneman Douglas
28	Everglades Habitat, and to preserve public resources by allowing
29	Wellington to direct its financial resources to developing,
30	preserving, and maintaining these natural areas for the benefit
31	of the public. In addition to the already existing 365-acre
32	Wellington Preserve that provides an environmental ecosystem,
33	flood protection, and recreational opportunities to Palm Beach
34	County residents, the addition of the Moncada property to the
35	Wellington Preserve will add an additional 45 acres of
36	landscaping, planting, hiking trails, equestrian trails, a
37	wildlife observation area, picnic structures, and an educational
38	kiosk; and will protect the natural characteristics of the site
39	and preserve its habitat for numerous listed species that live
40	in the area. The Wellington Preserve at the Marjory Stoneman
41	Douglas Everglades Habitat and the Moncada Property are more
42	particularly described as follows:
