35 | Be It Enacted by the Legislature of the State of Florida:

37 |       Section 1. Section 570.233, Florida Statutes, is created  
 38 | to read:

39 |       570.233 Florida Crop Diversification Commission; powers  
 40 | and duties.-

41 |       (1) The Florida Crop Diversification Commission, a  
 42 | commission as defined in s. 20.03(4), is created adjunct to the  
 43 | department. The commission shall be composed of the following  
 44 | nine members:

45 |       (a) The commissioner or his or her designee.

46 |       (b) The dean for research of the Institute of Food and  
 47 | Agricultural Sciences of the University of Florida or his or her  
 48 | designee.

49 |       (c) The following members, appointed by the commissioner  
 50 | based upon their knowledge and experience in agricultural

51 production, processing, or manufacturing:

52 1. Four members who are currently involved in agricultural  
53 production or who have been involved in agricultural production  
54 within the last 3 years.

55 2. One member who has experience in agricultural  
56 processing or manufacturing.

57 3. One member who has experience in the packing or  
58 processing of fresh agricultural products.

59 4. One member who has experience in agricultural marketing  
60 analysis and the viability of agricultural products.

61 (2) The commission shall do all of the following:

62 (a) Evaluate alternative agricultural crops and determine  
63 whether there exists one or more viable crops or products that  
64 would provide an economic benefit to growers using current  
65 agricultural infrastructure on land that has been taken out of  
66 production by diseases or adverse weather conditions.

67 (b) Contract for the design and implementation of the  
68 Florida Crop Diversification Initiative. The initiative must  
69 provide direct cash payments to nurseries and agricultural  
70 producers in this state in order to rapidly stimulate the  
71 adoption of alternative crops, moderate the required economic  
72 outlay, and speed the economic recovery of producers, packers,  
73 nurseries, processors, and communities. The entity with which  
74 the commission contracts for the Florida Crop Diversification  
75 Initiative must be a nonprofit organization that has a history

76 of focusing on alternative crops and has the organizational  
77 capacity to manage a statewide initiative and carry out the  
78 requirements of this paragraph.

79 (c) Develop best management practices for crops or  
80 products recommended by the commission.

81 (d) Assist local economic development councils in  
82 encouraging the development of manufacturing and processing  
83 facilities for new crops or products recommended by the  
84 commission.

85 (e) Publish the findings of the commission on an annual  
86 basis after review and approval by the commissioner.

87 (3) By July 1, 2026, and each July 1 thereafter, the  
88 commission shall submit a report to the Governor, the President  
89 of the Senate, and the Speaker of the House of Representatives  
90 which includes, at a minimum:

91 (a) Information about each crop or product recommended,  
92 detailing the environmental impact of each.

93 (b) An assessment of each recommended crop's suitability  
94 to this state's climate, and the expected economic benefit to  
95 growers and communities in this state.

96 (c) Recommendations for best practices to sustain and  
97 improve the agricultural industry in this state.

98 Section 2. For the 2024-2025 fiscal year, the sum of  
99 \$500,000 in nonrecurring funds is appropriated from the General  
100 Revenue Fund to the Department of Agriculture and Consumer
