46	(II) Internal combustion engine vehicle workers and workers
47	in the supply chain or repair services for internal combustion
48	engine vehicles;
49	(III) Workers in the building and construction trades; and
50	(IV) Any other affected workers.
51	d. "Transition worker" means a worker in this state who has
52	been laid off from employment in a transition-impacted industry
53	since January 1, 2023, or who is or will be laid off from
54	employment in a transition-impacted industry on or after July 1,
55	2024, and before January 1, 2035.
