An act relating to transportation facility designations; providing honorary designations of certain transportation facilities in specified counties; amending ch. 65-781, Laws of Florida; redesignating a specified bridge in St. Lucie County as "E.C. Summerlin Family Bridge"; directing the Department of Transportation to erect suitable markers; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Transportation facility designations; Department of Transportation to erect suitable markers.-

(1) That portion of I-75 between U.S. 17/Duncan Road and Harbor View Road in Charlotte County is designated as "Deputy Sheriff Christopher Taylor Memorial Highway."

(2) That portion of U.S. 19 between Palm View Road and Terra Ceia Road in Manatee County is designated as "Army Specialist Nicholas Panipinto Memorial Highway."

(3) The mid-block crossing and pedestrian hybrid beacon on that portion of E. University Avenue/S.R. 26 between N.E. 26th Terrace and S.E. 26th Terrace in Alachua County is designated as "Dylan Roberts Memorial Crosswalk."

(4) Those portions of the Gandy Bridge on U.S. 92 located

38 (8) That portion of Bay Avenue between W. 25th Street and  
 39 W. 27th Street in Sunset Islands in Miami-Dade County is  
 40 designated as "Abe Resnick Drive."

41 (9) That portion of S.W. 168th Street between U.S. 1 and  
 42 S.W. 89th Avenue in Miami-Dade County is designated as "Pastor  
 43 Rick Blackwood Street."

44 (10) That portion of S.R. 16 between C.R. 225 and Rifle  
 45 Range Road in Clay County is designated as "Gus Kopelousos  
 46 Memorial Highway."

47 (11) That portion of S.R. 997/Krome Avenue/W. 177th Avenue  
 48 between S.W. 8th Street and the entrance to the Miccosukee  
 49 Casino & Resort in Miami-Dade County is designated as "MICCO  
 50 WAY."
