and insert:

(10) That portion of S.W. 168th Street between U.S. 1 and S.W. 89th Avenue in Miami-Dade County is designated as "Pastor Rick Blackwood Street."

(11) That portion of S.R. 16 between C.R. 225 and Rifle Range Road in Clay County is designated as "Gus Kopelousos Memorial Highway."

(12) That portion of S.R. 997/Krome Avenue/W. 177th Avenue

25 designated as "Carol Jenkins Barnett Memorial Highway."
