I.Amendments Contained in Message:

House Amendment – 630783 to Senate Amendment - *Barcode* – 829028 (body with title)

II.Summary of Amendments Contained in Message:

House Amendment – **630783** removes all Senate provisions relating to district school board administrative efficiency.

The House amendment includes the following provisions not included in the Senate amendment:

- Council on the Social Status of Black Men and Boys: Transfers the council from the Department of Legal Affairs to Florida Memorial University; reduces quorum requirements from 11 to 9; allows electronic participation for quorum purposes; and adds notice requirements for public meetings held via communications media technology.
- Charter School Funding: Requires school districts to proportionally share discretionary sales surtax revenues with charter schools based on enrollment; sets expenditure, accounting, and reversion guidelines; applies to surtax levies after July 1, 2025.
- School Bus Trespass: Adds provisions addressing trespassing on school buses.
- Conversion Charter Schools: Requires parents applying for conversion charter schools to have children enrolled in the school; removes requirement for 50 percent teacher support; authorizes municipalities to establish "job engine" charter schools to attract employers and includes specific reporting and operational requirements.
- **District-Charter Financial Transparency**: Requires school districts to annually provide charter schools with financial reports on discretionary millage and surtax revenue.
- **Municipal Lease Negotiation**: Requires municipalities to negotiate rental fees with districts and prohibits removal of district property.
- **Private School Construction**: Allows certain private schools to construct facilities on eligible sites without rezoning or mitigation if they meet safety codes.
- **Cell Phone Use in Schools**: Limits teacher authority over classroom conduct rules and phone use to grades 9-12; requires designated phone areas in high schools; mandates full-day

- restrictions in elementary and middle schools; provides exceptions for educational and medical use.
- Certificates of Completion: Removes authority to issue certificates of completion and related conforming provisions; mandates documentation of alternative graduation paths for non-diploma students.
- **Graduation and Credit Flexibility**: Allows high school credits through equivalent or integrated courses and internships; marching band may substitute for PE credit.
- Credentialing for Students with Disabilities: Creates a new credentialing program for students with autism or those on a modified curriculum.
- **Dual Enrollment Agreements**: Requires dual enrollment agreements to specify transportation responsibilities and changes to scheduling.
- **Millage Revenue Use**: Adds liability insurance to the list of allowable expenditures from discretionary millage levy proceeds.
- Workforce Grants: Expands eligibility for the Workforce Development Capitalization Incentive Grant Program to include charter and job engine schools serving grades 6-12.
- **Mathematics Endorsement**: Requires the DOE to establish competencies for a math endorsement by August 2026, covering instructional and intervention strategies across key math domains.
- Cell Phone Policy Study: Directs the DOE to coordinate with six diverse school districts to study full-day phone bans in high schools; requires a legislative report and model policy addressing policy exceptions and discipline.
- Charter School Monitoring: Requires charter school sponsors to use the standard monitoring tool when reviewing a charter school's progress toward the goals set forth in its charter agreement.
