6 Remove lines 26-60 and insert:

7 (2) Members of the commission ~~so appointed~~ shall annually
 8 select one of their members as chair. The ~~Such~~ chair may be
 9 removed at any time for sufficient cause, by the affirmative
 10 vote of the majority of the members of the commission. If ~~In~~
 11 ~~case~~ the ~~said~~ office of chair becomes vacant by removal or
 12 otherwise, it the same may be filled for the unexpired term at
 13 any time by the commission from its members.

14 (3) (a) To ensure statewide representation, one member
 15 shall reside full-time within each of the five regions
 16 established by the commission. The five regions are as follows:

17 1. Northwest Region.

18 2. North Central Region.

19 3. Northeast Region.

20 4. Southwest Region.

21 5. South Region.

22 (b) The remaining two members shall be appointed as at-
23 large members, representing the state as a whole.

24 (4) (a) Each regional member must reside full-time within
25 the boundaries of his or her respective region at the time of
26 appointment and throughout his or her term of service.

27 (b) The at-large members are not subject to regional
28 residency requirements but must be residents of this state.

29 (5) (a) Members shall serve staggered terms of 3 years.

30 (b) A vacancy occurring during the term of a member shall
31 be filled in the same manner as the original appointment and for
32 the remainder of the unexpired term.

33 (c) A vacancy may not be filled by a member who resides in
34 the same region as a sitting member.

35 (6) (a) The commission is authorized to take all necessary
36 actions to define the geographic boundaries of the five regions.

37 (b) The Governor shall ensure compliance with this section
38 when appointing members to the commission.
