137 (b) (6) To increase school breakfast and universal school 138 breakfast program participation, each district school board 139 must, To the maximum extent practicable, make breakfast meals 140 available to students through alternative service models as 141 described in publications of the Food and Nutrition Service of 142 the United States Department of Agriculture for the federal 143 School Breakfast Program.
