 25 indicated, based on the population of his or her county. In  
 26 addition, compensation shall be made for population increments  
 27 over the minimum for each population group, which shall be  
 28 determined by multiplying the population in excess of the  
 29 minimum for the grouping times the group rate.

(b) Effective October 1, 2025, the population of the county as of April 1, 2025, shall be used to calculate the group rate under this subsection.

(2) Each ~~no~~ member of a governing body of a charter chartered county or a county with a consolidated form of government shall receive as salary the amount provided by the provisions of the county charter as of September 30, 2025. If a county charter authorizes the governing body to set its salary by ordinance, each member of the governing body shall receive as salary the amount provided by an ordinance adopted on or before April 1, 2025. As of October 1, 2025, any future adjustment shall be made only as provided in s. 145.20 ~~be deemed to be the equivalent of a county commissioner for the purposes of determining the compensation of such member under his or her respective charter.~~

66 special law, general law of local application, resolution, or  
67 supplement or from any other source is a misdemeanor of the  
68 first degree punishable as provided in ss. 775.082 and 775.083.  
69 This section does not apply to any supplemental compensation  
70 provided by a charter county or a county with a consolidated  
71 form of government, provided that any increase in such
