### SUMMARY

#### Effect of the Bill:

The bill amends the definition of “farm product” to include plants and plant products, regardless of whether the plants and plant products are edible or nonedible.

The bill revises the prohibition on governmental entities adopting or enforcing any ordinance, resolution, regulation, rule, or policy that prohibits, restricts, regulates, or otherwise limits an activity of a bona fide farm operation to include the collection, storage, processing, and distribution of farm products on agricultural land.

### ANALYSIS

#### **EFFECT OF THE BILL:**

The bill amends the definition of “[farm product](#)” to include plants and plant products,<sup>1</sup> regardless of whether the plants and plant products are edible or nonedible. (Section [1](#).)

The bill revises the prohibition on governmental entities<sup>2</sup> adopting or enforcing any ordinance, resolution, regulation, rule, or policy that prohibits, restricts, regulates, or otherwise limits an activity of a [bona fide farm operation](#) to include the collection, storage, processing, and distribution of farm products on agricultural land. (Section [1](#).)

The bill was approved by the Governor on June 13, 2025, ch. 2025-136, L.O.F., and will become effective on July 1, 2025.

### RELEVANT INFORMATION

#### **SUBJECT OVERVIEW:**

##### **Agriculture in Florida**

As of 2024, Florida had 44,400 farm operations<sup>3</sup> covering 9.7 million acres of farmland.<sup>4</sup> In 2023, Florida ranked first in the United States in the value of production for floriculture, Valencia oranges, sugarcane, watermelons and

sweet corn. The state ranked second in value of production for bell peppers, strawberries, tomatoes grown in the open, and non-Valencia oranges; ranked third nationally in cabbage and grapefruit; and ranked fourth nationally in peanuts.<sup>5</sup>

### **Regulation of Bona Fide Farm Operations**

To prevent duplication of regulation, a local or regional governmental entity<sup>6</sup> is prohibited from exercising any of its powers to adopt or enforce any ordinance, resolution, regulation, rule, or policy to prohibit, restrict, regulate, or otherwise limit an activity of a [bona fide farm operation](#) on land classified as agriculture land,<sup>7</sup> if such activity is:

- Regulated through implemented best management practices, interim measures, or regulations adopted as rules pursuant to ch. 120, F.S.,<sup>8</sup> by the Department of Environmental Protection, the Department of Agriculture and Consumer Services, or a water management district as part of a statewide or regional program; or
- Regulated by the U.S. Department of Agriculture, the U.S. Army Corps of Engineers, or the U.S. Environmental Protection Agency.<sup>9</sup>

### **Classification of Agricultural Land**

Under Florida law, a property appraiser must, on an annual basis, classify all lands within a county for tax assessment purposes as either agricultural or nonagricultural.<sup>10</sup> Subject to certain restrictions, only lands that are used primarily for bona fide agricultural purposes may be classified as agricultural.<sup>11</sup> For purposes of this classification, the term “bona fide agricultural purposes” means good faith commercial agricultural use of the land, which includes horticulture, floriculture, viticulture, forestry, dairy, livestock, poultry, bee, commercial tropical fish farming, aquaculture, algaculture, sod farming, and all forms of farm products and farm production.<sup>12</sup>

Currently, Florida law defines “[farm product](#)” as any plant<sup>13</sup> or any animal that is useful to humans and includes, but is not limited to, any product derived therefrom.<sup>14</sup>
