

1 A bill to be entitled
 2 An act relating to licensure requirements for
 3 surveyors and mappers; amending s. 472.013, F.S.;
 4 conforming a provision to changes made by the act;
 5 requiring the Board of Professional Surveyors and
 6 Mappers to establish and administer the 1st Step
 7 Florida Surveyors and Mappers Credentialing and
 8 Licensing Protocol as a temporary alternative pathway
 9 to licensure; providing requirements for eligibility
 10 to take the surveyor and mapper licensure examination
 11 under the protocol; providing for the expiration of
 12 licenses granted pursuant to the protocol; requiring
 13 the Department of Agriculture and Consumer Services to
 14 provide certain notice to applicants; reenacting s.
 15 472.015(4), F.S., relating to licensure, to
 16 incorporate the amendment made to s. 472.013, F.S., in
 17 a reference thereto; providing an effective date.

 19 Be It Enacted by the Legislature of the State of Florida:

 21 **Section 1. Section 472.013, Florida Statutes, is amended**
 22 **to read:**

23 472.013 Examinations; ~~prerequisites~~; alternative pathway
 24 to licensure.—

25 (1) A person desiring to be licensed as a surveyor and

26 mapper shall apply to the department for licensure.

27 (2) An applicant shall be entitled to take the licensure
28 examination to practice in this state as a surveyor and mapper
29 if the applicant is of good moral character and has satisfied
30 one of the following requirements or the requirements under
31 subsection (3):

32 (a) The applicant has received a bachelor's degree, its
33 equivalent, or higher in surveying and mapping or a similarly
34 titled program, including, but not limited to, geomatics,
35 geomatics engineering, and land surveying, from a college or
36 university recognized by the board and has a specific experience
37 record of 4 or more years as a subordinate to a professional
38 surveyor and mapper in the active practice of surveying and
39 mapping, which experience is of a nature indicating that the
40 applicant was in responsible charge of the accuracy and
41 correctness of the surveying and mapping work performed. Work
42 experience acquired as a part of the education requirement may
43 not be construed as experience in responsible charge.

44 (b) The applicant has received a bachelor's degree, its
45 equivalent, or higher in a course of study, other than in
46 surveying and mapping, at an accredited college or university
47 and has a specific experience record of 6 or more years as a
48 subordinate to a registered surveyor and mapper in the active
49 practice of surveying and mapping, 5 years of which shall be of
50 a nature indicating that the applicant was in responsible charge

51 of the accuracy and correctness of the surveying and mapping
52 work performed. The applicant must have completed a minimum of
53 25 semester hours from a college or university approved by the
54 board in surveying and mapping subjects or in any combination of
55 courses in civil engineering, surveying, mapping, mathematics,
56 photogrammetry, forestry, or land law and the physical sciences.
57 Any of the required 25 semester hours of study completed not as
58 a part of the bachelor's degree, its equivalent, or higher may
59 be approved at the discretion of the board. Work experience
60 acquired as a part of the education requirement may not be
61 construed as experience in responsible charge.

62 (3) The Legislature recognizes that it is imperative that
63 this state meet the increasing demand for surveyors and mappers.
64 Therefore, as a substitute for the degree requirements to take
65 the exams for licensure as outlined in subsection (2), the board
66 shall establish and administer a certification and licensing
67 program known as the 1st Step Florida Surveyors and Mappers
68 Credentialing and Licensing Protocol to provide a temporary
69 alternative pathway to licensure.

70 (a) Beginning January 30, 2026, pursuant to the protocol,
71 a person desiring to be licensed as a surveyor and mapper who
72 does not meet the requirements imposed under subsection (2) may
73 take the licensure examination to practice in this state as a
74 surveyor and mapper if he or she is of good moral character and
75 all of the following requirements are met:

76 1. The applicant has paid the fees required under s.
77 472.011.

78 2. The applicant provides a letter of recommendation to
79 the department from his or her employer or a prospective
80 employer, provided that such employer or prospective employer is
81 a licensed surveyor or mapper.

82 3. The applicant has worked as a subordinate to a licensed
83 surveyor or mapper for at least 4 years.

84 (b) Licensure granted pursuant to the protocol expires on
85 December 15, 2031. The department shall notify all persons who
86 apply for licensure under this subsection of this expiration
87 date and that they must have completed a minimum of 20 semester
88 hours from a college or university approved by the board in
89 surveying and mapping subjects or in any combination of courses
90 in civil engineering, surveying, mapping, mathematics,
91 photogrammetry, forestry, or land law and the physical sciences
92 as a condition of continuing to practice as a surveyor and
93 mapper after that date.

94 (c) This subsection is exempt from the prohibition on
95 licensure based solely on a passing score on the examination in
96 s. 472.015(3)(a).

97 (4) A person shall be entitled to take an examination for
98 the purpose of determining whether he or she is qualified as a
99 surveyor and mapper intern if:

100 (a) The person is in good standing in, or is a graduate

101 of, a bachelor degree program, its equivalent or higher, at an
102 accredited college or university and has obtained a minimum of
103 25 semester hours in surveying, mapping, mathematics,
104 photogrammetry, forestry, civil engineering, or land law and the
105 physical sciences, or any combination thereof; or

106 (b) The person has obtained, from an accredited college or
107 university, a minimum of 15 semester hours in surveying,
108 mapping, mathematics, photogrammetry, forestry, civil
109 engineering, or land law and the physical sciences, or any
110 combination thereof, and has a specific surveying and mapping
111 experience record of 2 or more years as a subordinate to a
112 registered surveyor and mapper.

114 This subsection may not be construed as a substitute for the
115 degree requirement to take the exams for licensure as outlined
116 in subsection (2).

117 (5)~~(4)~~ The board shall adopt rules providing for the
118 review and approval of schools and colleges and the courses of
119 study in surveying and mapping in such schools and colleges. The
120 rules shall be based on the educational requirements for
121 surveying and mapping as defined in s. 472.005. The board may
122 adopt rules providing for the acceptance of the approval and
123 accreditation of schools and courses of study by a nationally
124 accepted accreditation organization.

125 (6)~~(5)~~(a) Good moral character means a personal history of

126 honesty, fairness, and respect for the rights of others and for
127 the laws of this state and nation.

128 (b) The board may refuse to certify an applicant for
129 failure to satisfy this requirement only if:

130 1. There is a substantial connection between the lack of
131 good moral character of the applicant and the professional
132 responsibilities of a registered surveyor and mapper; and

133 2. The finding by the board of lack of good moral
134 character is supported by clear and convincing evidence.

135 (c) When an applicant is found to be unqualified for a
136 license because of a lack of good moral character, the board
137 shall furnish the applicant a statement containing the findings
138 of the board, a complete record of the evidence upon which the
139 determination was based, and a notice of the rights of the
140 applicant to a rehearing and appeal.

141 **Section 2. For the purpose of incorporating the amendment**
142 **made by this act to section 472.013, Florida Statutes, in a**
143 **reference thereto, subsection (4) of section 472.015, Florida**
144 **Statutes, is reenacted to read:**

145 472.015 Licensure.—

146 (4) The board shall certify for licensure any applicant
147 who satisfies the requirements of s. 472.013 and who has passed
148 the licensing examination. The board may refuse to certify any
149 applicant who has violated any of the provisions of s. 472.031.

150 **Section 3.** This act shall take effect July 1, 2025.
