A bill to be entitled
 An act relating to the City of Coral Springs and the
 City of Parkland, Broward County; reducing and
 contracting from the corporate limits of the City of
 Coral Springs and enlarging and extending the
 corporate limits of the City of Parkland approximately
 8.7 acres of land contiguous to the corporate limits
 of the City of Parkland; providing boundaries;
 providing construction; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. The present corporate limits of the City of
 Coral Springs, Broward County, Florida, are hereby reduced and
 contracted so as to exclude, from the territory presently within
 the City of Coral Springs corporate limits, and the present
 corporate limits of the City of Parkland, Broward County, are
 hereby enlarged and extended so as to include, effective
 September 15, 2025, in addition to the territory presently
 within the City of Parkland corporate limits, an approximately
 8.494 acre parcel of land, contiguous to the corporate limits of
 the City of Parkland, particularly described as follows:

A portion of Section 5, Township 48 South, Range 41 East, of
 Broward County, Florida; being more particularly described as

28 Commencing at the Northwest corner of the Southwest quarter
29 (S.W. 1/4) of said Section 5, said point also being the point of
30 beginning; thence South 89°53'02" East, along the South line of
31 the Northwest quarter (N.W. 1/4) of Section 5, a distance of
32 1,006.86 feet to the beginning of a curve concave Easterly,
33 having a chord bearing of South 06°30'12" East; thence along
34 said curve, having a radius of 290.00 feet, through a central
35 angle of 34°35'18", an arc distance of 175.07 feet to a point of
36 reverse curvature with a curve concave Westerly, having a chord
37 bearing of South 02°47'44" West; thence along said curve, having
38 a radius of 147.00 feet, through a central angle of 53°09'52",
39 an arc distance of 136.40 feet to the end of said curve; thence
40 South 29°22'53" West, a distance of 43.06 feet to the beginning
41 of a curve concave Northwesterly, having a chord bearing of
42 South 56°27'14" West; thence along said curve, having a radius
43 of 75.00 feet, through a central angle of 54°08'02", an arc
44 distance of 70.86 feet to a point of reverse curvature with a
45 curve concave Southeasterly, having a chord bearing of South
46 60°18'02" West; thence along said curve, having a radius of
47 200.00 feet, through a central angle of 46°26'25", an arc
48 distance of 162.11 feet to a point of reverse curvature with a
49 curve concave Northwesterly, having a chord bearing of South
50 55°05'02" West; thence along said curve, having a radius of

51 100.00 feet, through a central angle of 36°00'25", an arc
 52 distance of 62.84 feet to the end of said curve; thence North
 53 30°59'10" West, a distance of 136.65 feet; thence North
 54 89°53'02" West, a distance of 464.50 feet; thence North
 55 44°48'18" West, a distance of 308.15 feet to a point on the West
 56 line of the Southwest quarter (S.W. 1/4) of said Section 5;
 57 thence North 00°49'39" West, along the West line of the
 58 Southwest quarter (S.W. 1/4) of said Section 5, a distance of
 59 156.83 feet to the point of beginning.

 61 Said lands situate, lying and being in Broward County, Florida,
 62 containing 8.494 acres, more or less.

63 **Section 2.** The present corporate limits of the City of
 64 Coral Springs, Broward County, Florida, are hereby reduced and
 65 contracted so as to exclude, from the territory presently within
 66 the City of Coral Springs corporate limits, and the present
 67 corporate limits of the City of Parkland, Broward County,
 68 Florida, are hereby enlarged and extended so as to include,
 69 effective September 15, 2025, in addition to the territory
 70 presently within the City of Parkland corporate limits, an
 71 approximately 0.187 acre parcel of land, contiguous to the
 72 corporate limits of the City of Parkland, particularly described
 73 as follows:

 75 A portion of Section 5, Township 48 South, Range 41 East, of

76 Broward County, Florida; being more particularly described as

81 the West line of the Southwest quarter (S.W. 1/4) of said
82 Section 5, a distance of 156.83 feet; thence South 44°48'18"
83 East, a distance of 308.15 feet; thence South 89°53'02" East, a
84 distance of 464.50 feet; thence South 30°59'10" East, a distance
85 of 136.65 feet to the point of beginning; thence South 30°59'10"
86 East, a distance of 13.83 feet to the beginning of a curve
87 concave Southerly, having a chord bearing of North 72°16'00"
88 East; thence along said curve, having a radius of 930.00 feet,
89 through a central angle of 08°52'10", an arc distance of 143.96
90 feet to a point of reverse curvature with a curve concave
91 Northwesterly, having a chord bearing of North 53°02'29" East;
92 thence along said curve, having a radius of 90.00 feet, through
93 a central angle of 47°19'14", an arc distance of 74.33 feet to
94 the end of said curve; thence North 29°22'53" East, a distance
95 of 37.58 feet to the beginning of a non-tangent curve concave
96 Southeasterly, having a radial bearing of South 24°59'46" East
97 and chord bearing of South 58°04'15" West; thence along said
98 curve, having a radius of 177.72 feet, through a central angle
99 of 13°51'58", an arc distance of 43.01 feet to the end of said
100 curve; thence South 70°36'09" West, a distance of 41.82 feet;

101 thence South 58°27'42" West, a distance of 42.42 feet; thence
102 South 46°10'27" West, a distance of 27.73 feet; thence North
103 49°49'35" West, a distance of 12.17 feet; thence North 46°10'18"
104 East, a distance of 35.98 feet to the beginning of a curve
105 concave Southerly, having a chord bearing of North 59°37'45"
106 East; thence along said curve, having a radius of 150.00 feet,
107 through a central angle of 26°54'49", an arc length of 70.46
108 feet to the end of said curve; thence North 73°05'10" East, a
109 distance of 51.91 feet to the beginning of a curve concave
110 Northerly, having a chord bearing of North 61°49'32" East;
111 thence along said curve, having a radius of 70.00 feet, through
112 a central angle of 22°31'26", an arc distance of 27.52 feet to
113 the end of said curve; thence North 29°22'41" East a distance of
114 32.65 feet, to the beginning of a curve concave Northerly,
115 having a chord bearing of South 56°27'14" West; thence along
116 said curve, having a radius of 75.00 feet, through a central
117 angle of 54°08'02", an arc distance of 70.86 feet to a point of
118 reverse curvature concave Southeasterly, having a chord bearing
119 of South 60°18'02" West; thence along said curve, having a
120 radius of 200.00 feet, through a central angle of 46°26'25", an
121 arc distance of 162.11 feet to a point of reverse curvature with
122 a curve concave Northwesterly, having a chord bearing of South
123 55°05'02" West; thence along said curve, having a radius of
124 100.00 feet, through a central angle of 36°00'25", an arc
125 distance of 62.84 feet to the end of said curve, and the point

128 Said lands situate, lying and being in Broward County, Florida,
 129 containing 0.187 acres, more or less.

130 **Section 3.** This act may not be construed to affect or
 131 abrogate the rights of parties to any contract, whether the same
 132 be between Broward County and a third party or between
 133 nongovernmental entities or otherwise, which contracts are in
 134 effect before September 15, 2025.

135 **Section 4.** This act shall take effect upon becoming a law.
