Section 1. Section 775.085, Florida Statutes, is amended to read:

775.085 Evidencing prejudice while committing offense; reclassification.—

(1) (a) The penalty for any felony or misdemeanor shall be reclassified as provided in this subsection if the commission of such felony or misdemeanor evidences prejudice based in whole or in part on the gender, race, color, ancestry, ethnicity, religion, sexual orientation, national origin, homeless status,

or advanced age, or gender identity of any person the victim:

- 1. A misdemeanor of the second degree is reclassified to a misdemeanor of the first degree.
- 2. A misdemeanor of the first degree is reclassified to a felony of the third degree.
- 3. A felony of the third degree is reclassified to a felony of the second degree.
- 4. A felony of the second degree is reclassified to a felony of the first degree.
- 5. A felony of the first degree is reclassified to a life felony.
 - (b) As used in paragraph (a), the term:
- 1. "Advanced age" means that the $\underline{\text{person}}$ victim is older than 65 years of age.
- 2. "Gender identity" means a person's gender-related identity, appearance, or behavior, regardless of whether such gender-related identity, appearance, or behavior is different from that traditionally associated with the person's physiology or assigned sex at birth.
 - 3.2. "Homeless status" means that the person victim:
- a. Lacks a fixed, regular, and adequate nighttime residence; or
 - b. Has a primary nighttime residence that is:
- (I) A supervised publicly or privately operated shelter designed to provide temporary living accommodations; or
- (II) A public or private place not designed for, or ordinarily used as, a regular sleeping accommodation for human beings.

convincing evidence that it has been coerced, intimidated, or threatened in violation of this section has a civil cause of action for treble damages, an injunction, or any other appropriate relief in law or in equity. (b) As used in paragraph (a), the term "disability" "mental or physical disability" means a physical, psychological, or intellectual impairment that substantially limits one or more of a person's major life activities a condition of mental or physical incapacitation due to a developmental disability, organic brain damage, or mental illness, and one or more mental or physical limitations that restrict a person's ability to perform the normal activities of daily living.

- (2) A person or organization that establishes by clear and convincing evidence that it has been coerced, intimidated, or threatened in violation of this section has a civil cause of action for treble damages, an injunction, or any other appropriate relief in law or in equity. Upon prevailing in such civil action, the plaintiff may recover reasonable attorney fees and costs.

- (2) ACQUISITION AND PUBLICATION OF DATA.—The Governor, through the Florida Department of Law Enforcement, shall collect and disseminate data on incidents of criminal acts that evidence prejudice based on gender, race, religion, ethnicity, color, ancestry, sexual orientation, gender identity, disability, or national origin. All law enforcement agencies shall report

monthly to the Florida Department of Law Enforcement concerning such offenses in such form and in such manner as prescribed by rules adopted by the department. Such information shall be compiled by the department and disseminated upon request to any local law enforcement agency, unit of local government, or state agency.

Section 4. This act shall take effect July 1, 2025.
