development of rural communities and the economic stability and sustainability of farmers in this state.

- (d) Exists to serve its members beyond only offering medical benefit plans.
 - (e) Collects annual dues from its members.
 - (f) Was in existence before 1945.

- (g) Is composed of members who, collectively, are residents of the majority of counties in this state.
 - (3) A nonprofit agricultural organization:
- (a) May offer medical benefit plans to members of the nonprofit agricultural organization. Such plans are not insurance for purposes of the Florida Insurance Code.
- (b) Must provide a written disclaimer on or accompanying all applications and marketing materials for a medical benefit plan, regardless of whether the applications and marketing materials are distributed by or on behalf of the nonprofit agricultural organization. The disclaimer must read in substance: "Notice: This medical benefit plan is not a health insurance policy or health maintenance contract and is not subject to the regulatory requirements and consumer protections that apply to health insurance policies or health maintenance contracts under the Florida Insurance Code. The nonprofit agricultural organization offering this medical benefit plan is not an authorized insurer or authorized health maintenance organization in Florida, and the nonprofit agricultural

- (c) May not market or sell medical benefit plans through agents licensed by the department.
- (d) Must conduct an annual financial audit that is performed by an independent certified public accountant in accordance with generally accepted accounting principles and that is made available to the public by providing a copy upon request or by posting on the nonprofit agricultural organization's website.
 - Section 2. This act shall take effect July 1, 2025.
