Section 3. Subsection (2) of section 1002.63, Florida Statutes, is amended to read:

1002.63 School-year prekindergarten program delivered by public schools.—

- (2) Each school-year prekindergarten program delivered by a public school must comprise at least  $\underline{1,440}$  540 instructional hours.
- Section 4. Subsection (2) of section 1002.71, Florida Statutes, is amended to read:
  - 1002.71 Funding; financial and attendance reporting.-
- (2) A full-time equivalent student in the Voluntary Prekindergarten Education Program shall be calculated as follows:
- (a) For a student in a school-year prekindergarten program delivered by a private prekindergarten provider: 1,440 540 instructional hours.
- (b) For a student in a summer prekindergarten program delivered by a public school or private prekindergarten provider: 480 300 instructional hours.
- (c) For a student in a school-year prekindergarten program delivered by a public school: 1,440 540 instructional hours.

Except as provided in subsection (4), a student may not be reported for funding purposes as more than one full-time equivalent student.

Section 5. This act shall take effect July 1, 2025.
