- (3) The task force shall determine best practices for policies and procedures for immigration enforcement, including, but not limited to:
 - (a) Questioning persons about their immigration status.
- (b) Arresting and detaining unauthorized aliens when they are found in churches, day care centers, or schools, including how long an unauthorized alien may be detained.
- (4) The task force shall report on the feasibility of the creation of a database by law enforcement agencies that would contain statewide data showing demographic information on persons who have been arrested or detained, including factors such as race, gender, and age.
- (5) The task force shall hold its first meeting no later than April 1, 2025. The task force shall meet upon the call of the chair or a majority of its members. The task force shall elect a chair at its first meeting. The Department of Law Enforcement shall provide administrative support to the task force.
