1001.42 Powers and duties of district school board.—The  
district school board, acting as a board, shall exercise all  
powers and perform all duties listed below:

(17) PUBLIC INFORMATION AND PARENTAL INVOLVEMENT PROGRAM.—

(a) Adopt procedures whereby the general public can be  
adequately informed of the educational programs, needs, and  
objectives of public education within the district, including

26 district school board may adopt salary incentives or other

30 purposes of this subsection, an educational emergency exists in  
31 a school district if one or more schools in the district have a  
32 school grade of "D" or "F" or are persistently low-performing
