## ANALYSIS

### EFFECT OF THE BILL:

The bill designates October 14 of each year as “[Charlie Kirk](#) Day of Remembrance” and authorizes the Governor to annually issue a proclamation recognizing the [special observance](#). (Section [1](#))

## RELEVANT INFORMATION

### SUBJECT OVERVIEW:

#### [Charlie Kirk](#)

Charlie Kirk was born on October 14, 1993, in Arlington Heights, Illinois.<sup>1</sup> He rose to prominence as a conservative political activist when, at the age of 18 in 2012, he founded the nonprofit organization Turning Point USA.<sup>2</sup> Kirk built a national profile as a political commentator and campus speaker known for advocating for free speech and encouraging civic engagement among young people.<sup>3</sup> In his personal life, he married Erika Frantzve in May 2021 and the couple had two children together, a daughter born in August 2022 and a son born in May 2024.<sup>4</sup> Kirk’s life came to a tragic end on September 10, 2025, when he was fatally shot while speaking at an event at Utah Valley University.

#### [Special Observances](#)

Current law designates numerous special observances in Florida.<sup>5</sup> These designations, established by the Legislature, honor individuals, groups, events, or causes of public significance. Special observances generally serve

a ceremonial or education purpose, promoting public recognition or awareness rather than the closure of public offices or suspension of activities, as may occur with legal<sup>6</sup> or paid holidays.<sup>7</sup>

For example, November 7 of each year is designated as “Victims of Communism Day,” a special observance during which high school students must receive 45 minutes of instruction on the suffering endured by victims of communist regimes.<sup>8</sup> By contrast, “Gasparilla Day” is a legal holiday observed only in Hillsborough County during which all city, county, and state offices, and banking institutions may remain closed at their discretion.<sup>9</sup>

There are currently 37 special observances<sup>10</sup> and 26 legal holidays<sup>11</sup> established in law. The state recognizes nine paid holidays that are observed by all state branches and agencies.<sup>12</sup>
