(5) CONSTRUCTION BEST MANAGEMENT PRACTICES.—

(a) The Department of Environmental Protection shall
develop best management practices (BMPs) for the construction of
a solar facility. Such BMPs must include, but are not limited
to, all of the following:

24 update and revise its BMPs annually. As part of the update and
25 revision process, the department shall review all settlements,
26 consent decrees, judgments, and resolutions of civil cases since
27 2020 which relate to the construction of a solar facility.

29 facility shall implement all BMPs developed pursuant to
30 paragraph (a).

32 the subject of an application to construct a solar facility
33 submitted to a local governmental entity before July 1, 2021.
