4 roads; requiring state university and Florida College
5 System institution boards of trustees to redesignate
6 specified roads or portions of roads to certain names
7 relating to Charlie James Kirk within a specified time
8 period; requiring that state funds be withheld for any
9 university or institution that fails to redesignate a
10 road or portion of a roadway within such time period;
11 providing an effective date.

13 Be It Enacted by the Legislature of the State of Florida:

15 Section 1. (1) Each state university board of trustees, in
16 exercising its authority delegated by the Board of Governors of
17 the State University System, shall redesignate the following
18 roadways or portions of roadways, as applicable:

19 (a) The University of South Florida board of trustees shall
20 redesignate USF Alumni Drive as Charlie James Kirk Drive.

21 (b) The University of Central Florida board of trustees
22 shall redesignate Gemini Boulevard South as Charlie James Kirk
23 Boulevard.

24 (c) The Florida State University shall redesignate
25 Chieftain Way as Charlie James Kirk Road.

26 (d) The Florida Agricultural and Mechanical University
27 shall redesignate West Osceola Street as Charlie James Kirk
28 Street.

29 (e) The Florida Atlantic University shall redesignate

University Drive as Charlie James Kirk Drive.

(f) The Florida Gulf Coast University shall redesignate
FGCU Boulevard as Charlie James Kirk Boulevard.

(g) The Florida International University shall redesignate
Southwest 17th Street as Charlie James Kirk Street.

(h) The Florida Polytechnic University shall redesignate
Polytechnic Circle as Charlie James Kirk Circle.

(i) New College of Florida shall redesignate College Drive
as Charlie James Kirk Drive.

(j) The University of Florida shall redesignate Stadium
Road as Charlie James Kirk Road.

(k) The University of North Florida shall redesignate UNF
Drive as Charlie James Kirk Drive.

(l) The University of West Florida shall redesignate Campus
Drive as Charlie James Kirk Drive.

(2) Each Florida College System institution board of
trustees, in exercising its authority delegated by the State
Board of Education, shall redesignate the following roadways or
portions of roadways, as applicable:

(a) Broward College shall redesignate College Avenue as
Charlie James Kirk Avenue.

(b) Chipola College shall redesignate College Street as
Charlie James Kirk Street.

(c) College of Central Florida shall redesignate Southwest
26th Street as Charlie James Kirk Street.

(d) Daytona State College shall redesignate Pinecrest
Avenue as Charlie James Kirk Avenue.

(e) Eastern Florida State College shall redesignate Titan
Boulevard as Charlie James Kirk Boulevard.

96 Street as Charlie James Kirk Street.

97 (x) Seminole State College of Florida shall redesignate
98 College Drive as Charlie James Kirk Street.

99 (y) South Florida State College shall redesignate College
100 Drive as Charlie James Kirk Drive.

101 (z) State College of Florida, Manatee-Sarasota shall
102 redesignate 57th Avenue West as Charlie James Kirk Avenue.

103 (aa) Tallahassee State College shall redesignate Progress
104 Drive as Charlie James Kirk Drive.

105 (bb) Valencia College shall redesignate Valencia College
106 Drive as Charlie James Kirk Drive.

107 (3) State funds shall be withheld from any state university
108 or Florida College System institution whose board of trustees
109 fails to redesignate the roadway or portion of a roadway listed
110 in subsections (1) and (2), respectively, within 90 days after
111 the effective date of this act.

112 Section 2. This act shall take effect upon becoming a law.
