11 2. Any portion of the information provided under  
12 subparagraph 1. which would reveal information critical to state  
13 or national security is exempt from s. 119.07(1) and s. 24(a),  
14 Art. I of the State Constitution. This subparagraph is subject  
15 to the Open Government Sunset Review Act in accordance with s.  
16 119.15 and shall stand repealed on October 2, 2031, unless

17 reviewed and saved from repeal through reenactment by the  
18 Legislature.

19 **Section 2.** (1) Section 943.03102, Florida Statutes,  
20 requires the Chief of Domestic Security to provide written  
21 notice and findings to the Governor and Cabinet before  
22 designating an organization as a domestic terrorist organization  
23 or a foreign terrorist organization. To allow the chief to  
24 fulfill his or her role in making such a designation, the chief  
25 must consult with local, state, and federal law enforcement  
26 agencies; counter-terrorism organizations; and national security  
27 organizations and receive national and domestic security  
28 information that is highly sensitive in nature. For purposes of  
29 public safety, the Legislature intends to keep such information  
30 exempt from disclosure.

31 (2) The Legislature finds that it is a public necessity  
32 that any portion of information contained in the chief's written  
33 notice and findings provided to the Governor and Cabinet before  
34 designating an organization as a domestic terrorist organization  
35 or a foreign terrorist organization
