dependent district of Indian River County; providing
that the Board of County Commissioners of Indian River

revising the boundaries of the district; providing for
maintenance and use of certain canals; providing for
certain access to public records; providing an
effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Chapter 2017-203, Laws of Florida, is amended to read:

Section 1. Status and boundaries of Fellsmere Water Control District.—The Fellsmere Water Control District is declared to be a dependent ~~an independent~~ water control district and a public corporation of the state pursuant to chapters 189 and 298, Florida Statutes, and the lands lying within the area described as follows in Indian River County shall constitute the Fellsmere Water Control District:

649 Section 2. Minimum charter requirements.—In accordance
650 with s. 189.031(3), Florida Statutes, the following are the
651 minimum requirements for the charter of the Fellsmere Water
652 Control District:

653 (1) The district is organized and exists for all purposes
654 set forth in this act and chapter 298, Florida Statutes, as may
655 be amended from time to time.

656 (2) The district's charter may be amended only by special
657 act of the Legislature.

658 (3) The governing body of the Fellsmere Water Control
659 District shall be the members of the Board of County
660 Commissioners of Indian River County. As soon as practicable
661 after the County Commissioners of Indian River County have
662 assumed office, the commissioners shall meet to organize as the
663 governing board of the Fellsmere Water Control District. The
664 Clerk of the Circuit Court of Indian River County shall act as
665 secretary and treasurer without right to vote as a member of the
666 board or hold other office thereon without additional
667 compensation for his or her services, exercising all powers and

668 performing all duties as provided by this act. At this meeting,
669 the board shall elect a chair from among their number. In
670 accordance with chapter 189, Florida Statutes, this act, and ss.
671 298.11 and 298.12, Florida Statutes, as may be amended from time
672 to time, the governing board of the district shall be designated
673 the "Board of Supervisors of the Fellsmere Water Control
674 District" and shall be composed of three persons, who shall be
675 qualified to hold such office if they are landowners within the
676 district, residents of the state, and citizens of the United
677 States, elected on a 1 acre, one vote basis by the landowners in
678 the district; however, landowners owning less than 1 acre in the
679 aggregate shall be entitled to one vote. Landowners with more
680 than 1 acre shall be entitled to one additional vote for any
681 fraction of an acre greater than 1/2 acre owned when a
682 landowner's acreage has been aggregated for purposes of voting.
683 The membership and organization of the governing board shall be
684 as set forth in this charter and chapter 298, Florida Statutes,
685 as may be amended from time to time, provided this charter
686 controls with respect to any inconsistency.

687 (4) The compensation of the governing board members shall
688 be governed by this act and chapter 298, Florida Statutes, as
689 may be amended from time to time.

690 (5) The administrative duties of the governing board shall
691 be as set forth in this act and chapters 189 and 298, Florida
692 Statutes, as may be amended from time to time.

693 (6) Requirements for financial disclosure, meeting
694 notices, reporting, public records maintenance, and per diem
695 expenses for district officers and employees shall be as set

704 (5)~~(8)~~ The procedures for conducting district elections or
705 referenda and for qualification of electors shall be pursuant to

709 landowners present in person or represented by proxy at said

720 set forth in chapters 189 and 298, Florida Statutes, as may be

722 (9)(12) The district's geographic boundary shall be as set

724 Section 3. Maintenance and use of the Lateral "U" Canal,
725 Park Lateral Canal, and Main Canal.

726 (1) Lateral "U" Canal.—As described in section 1, the
727 western boundary of the Fellsmere Water Control District is the
728 centerline of the Lateral "U" Canal. The Fellsmere Water Control
729 District shall be responsible for the maintenance of the eastern
730 bank of the Lateral "U" Canal for the portion within the
731 district boundary and shall retain the right to utilize the full
732 width of said canal for all purposes permitted under applicable
733 water control laws and regulations. The district shall share
734 responsibility for the maintenance and aquatic vegetation of the
735 canal with the landowners bordering the west of the Lateral "U"
736 Canal until such time as a new water control district,
737 Headwaters Water Control District, is established west of and
738 adjacent to the Fellsmere Water Control District, at which time
739 the maintenance and aquatic vegetation management will transfer
740 to the Headwaters Water Control District as described below.

741

742 In the event Headwaters Water Control District is duly

743 established to the west of and adjacent to the Fellsmere Water
744 Control District, such newly established Headwaters Water
745 Control District shall assume full responsibility for all
746 maintenance and aquatic vegetation management within the entire
747 Lateral "U" Canal. The canal shall be maintained to the designed
748 level of service. The Fellsmere Water Control District shall
749 bear no further responsibility or liability for such maintenance
750 activities. The newly established Headwaters Water Control
751 District shall have the right to utilize the full width of the
752 Lateral "U" Canal for all purposes permitted under applicable
753 water control laws and regulations.

754 (2) Main Canal.—Upon the establishment of the Headwaters
755 Water Control District to the west of and adjacent to the
756 Fellsmere Water Control District, the Headwaters Water Control
757 District shall assume responsibility for the maintenance and
758 aquatic vegetation management of the Main Canal, from the
759 centerline of the Lateral "U" Canal eastward for a distance of
760 one mile. The canal shall be maintained to the designed level of
761 service. The Headwaters Water Control District shall have no
762 recourse to the Fellsmere Water Control District for such
763 responsibilities.

764 (3) Park Lateral Canal.—The Fellsmere Water Control
765 District shall be solely responsible for the maintenance
766 dredging and aquatic vegetation management of the Park Lateral
767 Canal located within the Fellsmere Water Control District

768 boundary without recourse to the Headwaters Water Control
769 District. The Headwaters Water Control District shall retain the
770 historic drainage rights through the Park Lateral Canal to the
771 Main Canal.

772
773 The Headwaters Water Control District shall have the right to
774 access, travel over, and cross all Fellsmere Water Control
775 District property as reasonably necessary to fulfill the
776 maintenance and management duties outlined in this section.
777 Additionally, the Headwaters Water Control District shall have
778 the right to utilize the full length of the Main Canal for all
779 purposes permitted under applicable water control laws and
780 regulations.

781
782 The Fellsmere Water Control District shall retain responsibility
783 for the maintenance and aquatic vegetation management of the
784 remaining portion of the Main Canal and shall have no recourse
785 to the Headwaters Water Control District for such
786 responsibilities. The canal shall be maintained to the designed
787 level of service.

788
789 Unless otherwise noted, all facilities lying within each
790 district boundary are the responsibility of that particular
791 district. Each district indemnifies and holds harmless the other
792 for any obstruction, interference, or other activity by each

793 district or its landowners that adversely impacts the flow and
794 drainage of water in the Lateral Canals or the Main Canal. To
795 the extent either district fails to maintain the Lateral Canals
796 or the Main Canal as set forth herein, the other district shall
797 have the right but not the obligation to perform such necessary
798 corrective action and seek reimbursement of costs, including
799 attorneys fees, from the non-complying district. In the event
800 that one district intends to undertake repairs or corrective
801 actions due to another district's non-compliance, the initiating
802 district shall provide the non-complying district with no less
803 than 30 days' written notice of its intent to perform such
804 corrective action. The non-complying district shall have the
805 opportunity to cure the non-compliance within this notice
806 period. If the non-complying district commences and diligently
807 pursues the necessary corrective actions within the 30-day
808 period, it shall not be held liable under this section.

809 Section 4. Public records.—Upon the establishment of the
810 Headwaters Water Control District to the west of and adjacent to
811 the Fellsmere Water Control District, the Headwaters Water
812 Control District may request and obtain copies of any public
813 records held by the Fellsmere Water Control District, in
814 accordance with applicable public records laws. The newly
815 established district shall be solely responsible for any costs
816 permitted under ch. 119, Florida Statutes, associated with the
817 retrieval, assembly, reproduction, and delivery of such public

818 records.

819 Section 5.3. Provisions of chapter 298, Florida Statutes,
820 made applicable.—The Fellsmere Water Control District is a
821 dependent ~~an independent~~ water control district and a public
822 corporation of this state. The provisions of state law
823 applicable to water control districts or subdistricts which are
824 embodied in chapter 298, Florida Statutes, as may be amended
825 from time to time, so far as not inconsistent with this act, are
826 declared to be applicable to the Fellsmere Water Control
827 District. The Fellsmere Water Control District shall have all of
828 the powers and authority conferred in this act and chapter 298,
829 Florida Statutes, as may be amended from time to time.

830 Section 6.4. Severability.—If any provision of this act or
831 the application thereof to any person or circumstance is held
832 invalid, the invalidity shall not affect other provisions or
833 applications of the act which can be given effect without the
834 invalid provision or application, and to this end the provisions
835 of this act are declared severable.

836 Section 7.5. Construction.—This act shall be construed as
837 a remedial act and shall be liberally construed to promote the
838 purpose for which it is intended.

839 **Section 2.** This act shall take effect October 1, 2026.
