7 Section 1. Paragraph (a) of subsection (4) of section
8 282.3185, Florida Statutes, is amended to read:

10 (4) CYBERSECURITY STANDARDS. —

11 (a)1. Each local government shall adopt cybersecurity
12 standards that safeguard its data, information technology, and
13 information technology resources to ensure availability,
14 confidentiality, and integrity. The cybersecurity standards must
15 be consistent with generally accepted best practices for

16 cybersecurity, including the National Institute of Standards and
17 Technology Cybersecurity Framework.

18 2. A local government may not impose cybersecurity
19 standards or processes on a vendor that exceed the standards or
20 processes established under this paragraph, except as necessary
21 to comply with state or federal laws, or with industry-specific
22 requirements applicable to regulated sectors. For purposes of
23 this paragraph, "vendor" means a sole proprietorship,
24 partnership, corporation, trust, estate, cooperative,
25 association, or other commercial entity that contracts with a
26 local government to provide information technology commodities
27 or services.

28 3. A local government may not adopt or enforce any
29 cybersecurity standards or processes that are inconsistent with
30 this paragraph for contracts entered into or amended on or after
31 July 1, 2026.
