Section 1. Subsection (9) of section 1001.212, Florida Statutes, is amended to read:

1001.212 Office of Safe Schools.—There is created in the Department of Education the Office of Safe Schools. The office

The office shall serve as a central repository for best practices, training standards, and compliance oversight in all matters regarding school safety and security, including prevention efforts, intervention efforts, and emergency preparedness planning. The office shall:

(9) Award grants to schools to improve the safety and security of schools school buildings based upon recommendations of the security risk assessment developed pursuant to subsection (1) or as provided in s. 1002.42(21).

- (21) SCHOOL SAFETY EQUIPMENT REQUIREMENTS.-
- (a) For purposes of this subsection, the term:
- 1. "Ballistic shield" means a mobile protective device meeting the National Institute of Justice's Level IIIA ballistic resistance standards or higher.
- 2. "Breaching tool" means a device designed to provide rapid access to locked or barricaded doors in an emergency, including, but not limited to, a Halligan bar, sledge hammer, or hydraulic breaching tool approved by a local law enforcement agency.
- 3. "Campus" means the grounds and facilities of a private school where students are regularly educated.

(b) Each private school must have at least one breaching tool and one ballistic shield on each campus of the school for use in the event of an active assailant or other lifethreatening incident. - (c) Each private school may use existing grants from the School Hardening Grant Program as funded by the Legislature or may use other available state or private funds to meet the requirements of this subsection.

- (6) SAFETY AND SECURITY BEST PRACTICES.—Each district school superintendent shall establish policies and procedures for the prevention of violence on school grounds, including the assessment of and intervention with individuals whose behavior poses a threat to the safety of the school community.
