## ANALYSIS

### **EFFECT OF THE BILL:**

The resolution condemns the ongoing persecution of Christians in Nigeria and calls for Nigeria's redesignation as a [Country of Particular Concern](#).

## RELEVANT INFORMATION

### **SUBJECT OVERVIEW:**

#### Boko Haram

Boko Haram is an Islamic sectarian movement, founded in 2002 in northeastern Nigeria.<sup>1</sup> Since 2009, the group has carried out assassinations and large-scale acts of violence in Nigeria.<sup>2</sup> Boko Haram's attacks have occurred primarily in Nigeria's northeast, north-central, and central states and often focus on police, military, and government targets, as well as Christian churches and schools and Muslim individuals who are critical of the group.<sup>3</sup>

#### Widespread Violence

Estimates vary regarding the levels of reported violence against Christians in Nigeria. According to one report, between July 2009 and April 2024, approximately 52,250 Christians were killed in the country for nonviolently professing their faith.<sup>4</sup> Another report found that just under 53,000 civilians, both Muslims and Christians, have

been killed in targeted political violence since 2009.<sup>5</sup> Additionally, one report indicates that approximately 19,000 churches have been attacked or destroyed since 2009,<sup>6</sup> and another estimates that 5 million Christians have been displaced within the country.<sup>7</sup>

### County of Particular Concern

Under the International Religious Freedom Act (IRFA) of 1998, the President of the United States must annually review the status of religious freedom in every country and designate any nation whose government engages in or tolerates “particularly severe violations of religious freedom” as a Country of Particular Concern (CPC).<sup>8</sup> The law defines particularly severe violations as “systematic, ongoing, egregious violations of religious freedom,” including violations such as:

- Torture;
- Prolonged detention without charges;
- Forced disappearance; or
- Other flagrant denial of life, liberty, or security of persons.<sup>9</sup>

On October 31, 2025, President Trump designated Nigeria as a Country of Particular Concern.<sup>10</sup>

### U.S. Strike in Nigeria

On December 25, 2025, U.S. forces launched airstrikes against ISIS in Nigeria. President Trump stated that the strike was a consequence for the militant group’s killing of Christians.<sup>11</sup> A Pentagon official reported the agency worked with the Nigerian government to carry out the strikes.<sup>12</sup>
